Mr Muhammad Mahboob, Deputy Secretary, Services and General Administration Department and Mr Mohsin Bukhari, Deputy Director, Law & Parliamentary Affairs Department attended the meetings as Expert Advisors. Mr Faiz-ul-Basit, Additional Secretary, Provincial Assembly of the Punjab functioned as Secretary to the Committee.

Mr Salman Ghani, Deputy Commissioner, Faisalabad apprised the Committee that no development schemes had been approved either by him or the Commissioner, Faisalabad in the constituency of the Mover by entertaining fake letter pad of Khawaja Muhammad Islam. He explained that more than 400 to 500 applications were submitted in the office of the Deputy Commissioner, Faisalabad and more than 80 applications were submitted in the office of the Commissioner, Faisalabad by general public on daily basis. Those applications had been sent to the concerned quarters and were entertained after complete scrutiny. He assured the Committee that he was ready to satisfy the Mover in case of any breach of his privilege.
