The Punjab Development of Cities Act, 1976 (Pb.Act, xxix) کے Section 35 of 1976 میں provided ہے کہ:

35 (I) The Authority shall prepare for every year, a report of the activities during that year and submit the report to the Government in such form and on or before such date as may be prescribed.

The report referred to in sub-section (I) shall be laid before the Provincial Assembly of the Punjab within six months of its receipt by the Government.

مذکورہ رپورٹ کی اہمیت اس امر سے واضح ہو جاتی ہے کہ اس رپورٹ میں مندرجہ ذیل امور کو deal کرنا مقصود ہوتا ہے۔

"The Development of cities Act, was enacted in 1976 and brought into operation to establish a comprehensive system of planning and development in order to improve the quality of life in the cities of the Punjab establish and integrated development approach and a continuing process of planning and development, to ensure optimum utilization of resources economical and effective utilization of land and to evolve policies and programmes, relating to the improvement of the environment of Housing, Industrial development, Traffic, Transportation, Health, Education, Water supply, Sewerage, Drainage, Solid Waste disposal etc.
