3. PRIVILEGE MOTION NO. 13 OF 2015

Sardar Vickas Hasan Mokal:

I hereby give notice of a Privilege Motion which requires immediate intervention of the Assembly. The matter is that I would like to draw your attention to a matter of grave importance and personal insult as member of Punjab Assembly. On 9<sup>th</sup> April 2015 (8.00 pm approx) I visited Garden Town Police Station and met the Investigating Officer. I asked for an FIR to the I/O. Asad Abbas was sitting here and he interrupted me by say "اوے تمیز نال گل کر" I replied by saying I am not talking / addressing you and who are you? He replied "I'm SHO" I introduced myself and his reply was "تیرے دروغے بڑے ایم پی اے دیکھے نے". He got up and left the room. I Called SP operations, Bilal Yaseen Minister Food and SP Investigation and informed all these of the insult. Asad Abbas afterwards not only locked the main gate of the Police Station but also came to me again, put his hand on my shoulder along with 2-3 police officers and said to my face "کر لیا ای فون؟ کی پوٹ لیا ہے میرا؟" I replied that I have talked with SP operations and he is sending DSP and I will only talk to him. Sir, if this is the disrespect I am going to receive from an Sub Inspector while I am doing Public Service I must lodge my embarrassment in the honorable Assembly. Kindly refer this incident to the Privilege Committee. I shall further elaborate on this matter to the Committee. Therefore, it is requested that notice of Privilege Motion may be held in order and be referred to the Committee on Privileges for consideration and report.
