REPORT OF THE COMMITTEE ON PRIVILEGES REGARDING PRIVILEGE MOTION NO. 17/2014 MOVED BY SARDAR ALI RAZA KHAN DRESHAK, MPA (PP-247)

Privilege Motion No. 17/2014 moved by Sardar Ali Raza Khan Dreshak, MPA (PP-247) (Annexed) was referred to the Committee on Privileges on 15 May, 2014. The Committee considered the Privilege Motion in its meeting held on 10 July 2014.

تحریک استحقاق نمبر 17 بابت 2014

میں حال ہی میں وقوع پذیر ہونے والے ایک اہم اور فوری مسئلہ کو زیر بحث لانے کیلئے تحریک استحقاق پیش کرتا ہوں جو اسمبلی کی فوری دغل اندازی کا متقاضی ہے۔ معاملہ یہ ہے کہ

سردار علی رضا خان دریشک:

The Walled City of Lahore Act 2012 کے Section 57 کے تحت within three months of end of a financial year پر سالانہ رپورٹ اسمبلی میں پیش کرنا حکومت پر لازم ہے۔

"57. Annual report.- (1) the Director General shall, within three months of the end of a financial year, submit annual Performance report to the Authority enumerating all the activities, developmental initiatives undertaken and targets achieved during the previous financial year for the betterment of the Walled City.

(2) The Authority shall publish the report for public information and submit the same to the Government which shall lay the report in the Provincial Assembly of the Punjab.

یہ ایکٹ اسمبلی نے 30 مارچ 2012 کو پاس کیا اور 18 اپریل 2012 کو پنجاب گزٹ میں نوٹیفائی ہوا۔ مالی سال 2012-13ء جو کہ 30 جون 2013 کو ختم ہو گیا تھا لیکن والدٹسٹی لاہور نے اپنی سالانہ کارکردگی کی رپورٹ ابھی تک اسمبلی میں پیش نہیں کی۔ اسی طرح قواعد انضباط کار صوبائی اسمبلی پنجاب 1997ء کے قاعدہ (a) 70 کا متن یوں ہے کہ:-

"70 (a) the question shall relate to a privilege granted by the Constitution, the law or the rules made under any law."

مذکورہ ایکٹ اور پنجاب اسمبلی کے مذکورہ Provisions اور تقاضوں کے باوجود والدٹسٹی لاہور نے اپنی سالانہ رپورٹ برائے مالی سال 2012 - 2013 پیش نہ کر کے نہ صرف میرا بلکہ اس معزز ایوان کا استحقاق مجروح ہوا ہے۔ لہذا میری اس تحریک کو ایوان میں پیش کرنے کی اجازت دی جائے اور اسے باضابطہ قرار دیتے ہوئے مجلس استحقاقات کے سپرد کیا جائے۔
