PROVINCIAL ASSEMBLY OF THE PUNJAB REPORT OF THE COMMITTEE ON PRIVILEGES REGARDING PRIVILEGE MOTION NO. 18/2014 MOVED BY SARDAR ALI RAZA KHAN DRESHAK, MPA (PP-247)

Privilege Motion No. 18/2014 moved by Sardar Ali Raza Khan Dreshak, MPA (PP-247) (Annexed) was referred to the Committee on Privileges on 15 May, 2014. The Committee considered the Privilege Motion in its meeting held on 6 June 2014.

3. Mr Maqbool Ahmad, Secretary (Colonies), Board of Revenue, Punjab and Mr Mohsin Bukhari, Deputy Director, Law & Parliamentary Affairs Department, Punjab, attended the meeting as Expert Advisors. Hafiz Muhammad Shafiq Adil, Additional Secretary (Legislation), Provincial Assembly of the Punjab functioned as Secretary to the Committee.

4. Mr Maqbool Ahmad, Secretary (Colonies), Board of Revenue, Punjab apprised the Committee that Thal Development Authority was constituted under section-3 of the Thal Development Authority Act 1949. He further apprised the Committee that the Thal Development Authority had been dissolved w.e.f. 1-6-1969 through Notification No.S-III-2-68/67(1247) dated 31-05-1969 and the assets and liabilities of the Thal Development Authority had been transferred to various Departments. Hence the laying of reports before the Assembly was not necessary.


5. Sardar Ali Raza Khan Dreshak, MPA (PP-247)/Mover and the members of the Committee were satisfied with the explanation given by Mr Maqbool Ahmad, Secretary (Colonies), Board of Revenue, Punjab. Hence, the Mover did not press his Privilege Motion.

6. The Committee, unanimously, decided to recommend to the Assembly that the Privilege Motion may be treated as disposed of, being not pressed by the Mover.

Section 49-B&C کے The Thal Development Act, 1949 کے تحت تھل ڈویلپمنٹ کی سالانہ رپورٹ ہر مالی سال کے اختتام پر اسمبلی میں پیش کرنا حکومت پر لازم ہے۔

"49-B. Submission of annual report to Government.- (1) The Authority shall, as soon as possible after the end of every financial year, submit and annual report to Government on the conduct of its affairs for that year.

49-C. Submission of accounts and Annual Report, etc. to the Provincial Assembly.- (1) The statement of accounts of the Authority referred to in sub-section (4) of section 49-A, together with the report of the Comptroller and Auditor General of Pakistan, and the Annual Report referred to in section 49-B, shall be placed by Government before the Provincial Assembly of Punjab as soon as possible.

مگر حکومت نے مالی سال 2012 اور مالی سال 2013 کے اختتام پر سالانہ رپورٹ ابھی تک اسمبلی میں پیش نہیں کی۔ اسی طرح قواعد انضباط کار صوبائی اسمبلی پنجاب 1997 کے قاعدہ (a) 70 کا متن یوں ہے کہ:-

"70 (a) the question shall relate to a privilege granted by the Constitution, the law or the rules made under any law."

مذکورہ ایکٹ اور پنجاب اسمبلی کے مذکورہ Provisions اور تقاضوں کے باوجود تھل ڈویلپمنٹ کی سالانہ رپورٹیں مالی سال 2012 اور 2013 کی پیش نہ کر کے نہ صرف میرا بلکہ اس معزز ایوان کا استحقاق مجروح ہوا ہے۔ لہذا میری اس تحریک کو ایوان میں پیش کرنے کی اجازت دی جائے اور اسے باضابطہ قرار دیتے ہوئے مجلس استحقاقات کے سپرد کیا جائے۔
