معالمہ یہ ہے کہ The Punjab Examination Commission Act 2010 عالمہ یہ ہے کہ کے تحت پنجاب ایگز امینیشن کمیشن سالانه کار کردگی رپورٹ ہر سال اسمبلی میں پیش کر ناحکومت پرلازم ہے۔

16. Annual report.- (1) The Commission shall submit an annual report to the Government which shall include-

(a) A comprehensive statement of the work and activities of the Commission during the preceding financial year, including the details of the examinations and the research work conducted during the year;

(b) Recommendations about the strategy to improve the curricula, Teaching methodology and inputs required for the quality elementary education;

(c) Statement of accounts and audit report; and

(d) Such other matters as may be prescribed and as the Commission may consider appropriate.

(2) The Government shall, within thirty days of receiving the report from the Commission, give notice for laying the report in the Provincial Assembly of the Punjab, and shall lay the report in the Assembly in its first available session thereafter.

یہ ایکٹ اسمبلی سے مورخہ 14 جولائی 2010 کو پاس ہوا اور مورخہ 20 جولائی 2010 کو پنجاب گزیے میں نوٹے اکی ہوا، حکومت پر لازم نھا کہ ایک سال یعنی 20 جولائی 2011 کے بعد first available session میں اپنی سالانہ رپورٹ پیش کرتی، مگر حکومت نے تین سالوں 2011، 2012 اور 2013 کی سالانہ کارکر دگی رپورٹیں مقررہ مدت گزرنے کے باوجود ابھی تک اسمبلی میں پیش نہیں کیں۔اسی طرح قواعد انضباط کار صوبائی اسمبلی پنجاب1997 کے قاعدہ (70(a) متن یوں ہے کہ:

"70 (a) the question shall relate to a privilege granted by the Constitution, the law or the rules made under any law."

مذکورہ ایکٹ اور پنجاب اسمبکی کے مذکورہ Provisions اور تقاضوں کے باوجود حکومت نے پنجاب ایگزامینیش کمیش کی سالانه کار کر دگی رپورٹیس تین سالوں 2011، 2012 اور 2013 پیش نه کر کے نہ صرف میرا بلکہ اس معزز ایوان کااستحقاق مجر وح ہوا ہے۔ لہذا میری اس تخریک کواپوان میں پیش کرنے کی اجازت دی جائے اور اسے باضابطہ قرار دیتے ہوئے مجلس استحقاقات کے سیر دکیا جائے۔
