PROVINCIAL ASSEMBLY OF THE PUNJAB REPORT OF THE COMMITTEE ON PRIVILEGES REGARDING PRIVILEGE MOTION NO. 23/2015 MOVED BY SARDAR ALI RAZA KHAN DRESHAK, MPA (PP-247)

Privilege Motion No. 23/2015 moved by Sardar Ali Raza Khan Dreshak, MPA (PP-247) (Annexed) was referred to the Committee on Privileges on 19 October 2015. The Committee considered the Privilege Motion in its meetings held on 27 October 2015 and 25 March 2016.

صوبائی اسمبلی پنجاب

تحریک استحقاق نمبر 23 بابت 2015

میں حال ہی میں وقوع پذیر ہونے والے ایک اہم اور فوری مسئلہ کو زیر بحث لانے کیلئے تحریک استحقاق پیش کرتا ہوں جو اسمبلی کی فوری دخل اندازی کا متقاضی ہے۔ معاملہ یہ ہے کہ

سردار علی رضا خان دریشک:

The Lahore Ring Road Authority Act, 2011 کے Section 14 کے تحت within three months of the close of a financial year پر لاہور رنگ روڈ اتھارٹی کی سالانہ رپورٹ اسمبلی میں پیش کرنا حکومت پر لازم ہے۔

14. Annual report.- (1) The Authority shall, within three months of the close of a financial year, submit to the Government an annual performance report.
- (2) The report shall consist of-
- (a) the statement of accounts and audit reports of the Authority;
- (b) a comprehensive statement of the work and activities of the Authority during the preceding financial year and its proposed projects and schemes; and
- (c) such other matters as may be prescribed or as the Council may specify or as the Authority may consider appropriate.
- (3) The Government shall, within two months of receiving the report from the Authority, give notice for laying the report in the Provincial Assembly of the Punjab, and shall lay the report in the first available session of the Assembly.

یہ ایکٹ اسمبلی نے 23 جون 2011 کو پاس کیا اور 6 جولائی 2011 کو پنجاب گزٹ میں نوٹیفائی ہوا۔ مالی سال 2011-12 جو کہ 30 جون 2012 کو ختم ہو گیا تھا، لیکن حکومت نے ابھی تک لاہور رنگ روڈ اتھارٹی کی سالانہ کارکردگی کی دو سالوں کی رپورٹیں اسمبلی میں پیش نہیں کیں۔ اسی طرح قاعدہ انشباط کار صوبائی اسمبلی پنجاب 1997 کے قاعدہ (a) 70 کا متن یوں ہے کہ

“70 (a) the question shall relate to a privilege granted by the Constitution, the law or the rules made under any law.”

مذکورہ ایکٹ اور پنجاب اسمبلی کے مذکورہ Provisions اور تقاضوں کے باوجود حکومت نے لاہور رنگ روڈ اتھارٹی کی سالانہ رپورٹیں برائے مالی سال 2011-12 اور 2012-13 پیش نہ کر کے نہ صرف میرا بلکہ اس معزز ایوان کا استحقاق مجروح کیا ہے۔ لہذا میری اس تحریک کو ایوان میں پیش کرنے کی اجازت دی جائے اور اسے باضابطہ قرار دیتے ہوئے مجلس استحقاقات کے سپرد کیا جائے۔
