صوبائی اسمبلی پنجاب

تحریک استحقاق نمبر 2 بابت 2015

میں حال ہی میں وقوع پذیر ہونے والے ایک اہم اور فوری مسئلہ کو زیر بحث لانے کیلئے تحریک استحقاق پیش کرتا ہوں جو اسمبلی کی فوری دخل اندازی کا متقاضی ہے۔ معاملہ یہ ہے کہ

سردار علی رضا خان دریشک:

The Punjab Power Development Board Act, 2011 کے تحت within three months of the conclusion of a calendar year پر سالانہ رپورٹ اسمبلی میں پیش کرنا حکومت پر لازم ہے۔

16. Annual report.- (1) The Board shall, within three months of the conclusion of a calendar year, submit an annual performance report to the Government.

(2) The report shall consist of-

- (a) the statement of accounts and audit reports of the Board and any organization established by the Board;
- (b) a comprehensive statement of the work and activities of the Board during the preceding year; and
- (c) such other matters as may be prescribed or as the Board may consider appropriate.

(3) The Government shall, within two months of receiving the report from the Board, give notice for laying the report in the Provincial Assembly of the Punjab, and shall lay the report in the Provincial Assembly at the earliest.

یہ ایکٹ اسمبلی نے 15 ستمبر 2011 کو پاس کیا اور 3 اکتوبر 2011 کو پنجاب گزٹ میں نوٹیفائی ہوا۔ سیکنڈر سال 2012 جو 31 دسمبر 2012 کو ختم ہو گیا تھا، لیکن حکومت نے ابھی تک پنجاب پاور ڈویلپمنٹ بورڈ کی سالانہ کارکردگی، پچھلے دو سالوں کی رپورٹیں اسمبلی میں پیش نہیں کیں۔ اسی طرح تو اہمہمہ الضابطہ کار صوبائی اسمبلی پنجاب 1997 کے قاعدہ (a) 70 کا متن یوں ہے کہ

"70 (a) the question shall relate to a privilege granted by the Constitution, the law or the rules made under any law."

مذکورہ ایکٹ اور پنجاب اسمبلی کے مذکورہ Provisions اور تقاضوں کے باوجود حکومت نے پنجاب پاور ڈویلپمنٹ بورڈ کی سالانہ رپورٹیں سال 2012 اور 2013 میں پیش نہ کر کے نہ صرف میرا بلکہ اس معزز ایوان کا استحقاق مجروح کیا ہے۔ لہذا میری اس تحریک کو ایوان میں پیش کرنے کی اجازت دینی چاہئے اور اسے باضابطہ قرار دیتے ہوئے مجلس استحقاقات کے سپرد کیا جائے۔
