تحریک استحقاق نمبر 25 بابت 2014

سر دار علی رضا خان دریشک: میں حال ہی میں وقوع پذیر ہونے والے ایک اہم اور فوری مسئلہ کو زیر بحث لانے کیلئے تحریک استحقاق پیش کرتا ہوں جو اسمبلی کی فوری دخل اندازی کا متقاضی ہے۔ معاملہ یہ ہے کہ The Sasti Roti Authority Act 2010 کے Section-31 کے تحت the end of a financial year پر سالانہ رپورٹ اسمبلی میں پیش کرنا حکومت پر لازم ہے۔

31. Annual Report.-(1) The Authority shall submit annual report of its activities to the Government at the end of a financial year.

(2) The Authority shall circulate a quarterly report of its activities to all the Members in the prescribed manner.

(3) The Government shall lay the annual report of the Authority in the Provincial Assembly of the Punjab.

یہ ایکٹ اسمبلی نے 15 جولائی 2010 کو پاس کیا اور 2 اگست 2010 کو پنجاب گزٹ میں نوٹیفائی ہوا۔ مالی سال 2010-11 جو کہ 30 جون 2011 کو ختم ہو گیا تھا لیکن حکومت نے سستی روٹی اتھارٹی کی سالانہ کارکردگی کی رپورٹ ابھی تک اسمبلی میں پیش نہیں کی۔ اسی طرح قواعد و انضباط کار صوبائی اسمبلی پنجاب 1997 کے قاعدہ (a) 70 کا متن یوں ہے کہ:-

"70(a) the question shall relate to a privilege granted by the Constitution, the law of the rules made under any law."

مذکورہ ایکٹ اور پنجاب اسمبلی کے مذکورہ Provisions اور تقاضوں کے باوجود حکومت نے سستی روٹی اتھارٹی کی سالانہ رپورٹس برائے مالی سال 2010-11، 2011-12 اور 2012-13 پیش نہ کر کے نہ صرف میرا بلکہ اس معزز ایوان کا استحقاق مجروح ہوا ہے۔ لہذا میری اس تحریک کو ایوان میں پیش کرنے کی اجازت دی جائے اور اسے باضابطہ قرار دیتے ہوئے مجلس استحقاقات کے سپرد کیا جائے۔
