Mr Muhammad Mehmood-ul-Hassan, Deputy Secretary, Home Department, Lahore Mr Qaisar Ali, AIG (Legal), Punjab Lahore and Mr Mohsin Bukhari, Deputy Director, Law & Parliamentary Affairs Department, Punjab, attended the meetings as Expert Advisors. Hafiz Muhammad Shafiq Adil, Additional Secretary (Legislation), Provincial Assembly of the Punjab functioned as Secretary to the Committee.
- 4. In the meeting of the Committee held on 25 Feburary 2014, Ch Aamar Sultan Cheema MPA/Mover stated that he had received the complete items recovered from the decoits as per FIR. He added that he wanted some improvements in the investigation procedure for the betterment of a common citizen in order to avoid the complications that he faced. So the Committee on Privileges, constituted a Committee under the convenership of Dr Azeem Leghari, DIG (Legal) Punjab to probe into the matter and make concrete recommendations.

- In the meeting of the Committee held on 4 June, 2014 the representative of the Legal 5. Branch (Police Department) Punjab apprised the Committee that some amendments were proposed in the existing investigation procedure. As the draft will be vetted by the Provincial Police Officer, Punjaby the same will be forwarded to the Prosecution Department for further process.
- Ch Aamar Sultan Cheema, MPA (PP-32)/Mover and the members of the Committee were satisfied with the explanation given by Mr Qaisar Ali, AIG (Legal). Hence, the Mover did not press his Privilege Motion.
- 7. The Committee, unanimously, decided to recommend to the Assembly that the Privilege Motion, may be treated as disposed of, being not pressed by the Mover.
