Privilege Motion No. 7/2014 moved by Mr Amjad Ali Javaid, MPA (PP-86) (Annexed) was referred to the Committee on Privileges on 20 March, 2014. The Committee considered the Privilege Motion in its meetings held on 27 March 2014 and 12 January, 2015.

Mian Abrar Ahmad, Additional Secretary, Government of the Punjab, Forestry, Wildlife and Fisheries Department and Mr Mohsin Bukhari, Deputy Director, Law & Parliamentary Affairs Department, Punjab attended the meetings as Expert Advisors. Hafiz Muhammad Shafiq Adil, Special Secretary, Provincial Assembly of the Punjab functioned as Secretary to the Committee.

Mr Muhammad Mukhtar, Assistant Commissioner Rajanpur apprised the Committee that a joint investigation team of the Revenue Department and the Forest Department had investigated the matter minutely. The team after visiting the site and thrashing out the record had found that neither Deputy Speaker, Provincial Assembly of the Punjab nor any member of his family was involved in illegal occupation/cultivation of the land owned by the Government. Mian Abrar Ahmad, Additional Secretary, Government of the Punjab, Forestry, Wildlife and Fisheries Department also endorsed the view point of the Assistant Commissioner Rajanpur.

5. Mr Amjad Ali Javaid, MPA (PP-86)/Mover and the members of the Committee were satisfied with the explanation given by them, therefore, the Mover did not press his Privilege Motion.

6. The Committee, unanimously, decided to recommend to the Assembly that the Privilege Motion may be treated as disposed of, being not pressed by the Mover.
