PROVINCIAL ASSEMBLY OF THE PUNJAB REPORT OF THE STANDING COMMITTEE ON COOPERATIVES REGARDING STARRED QUESTION NO.8445 ASKED BY MR EHSAN RIAZ FATYANA, MPA (PP-58)

3. Mr Muhammad Ayub, President, the Punjab Provincial Cooperative Bank Limited, and Mr Mohsin Bukhari, Deputy Director, Law and Parliamentary Affairs Department represented their Departments. Mr Faiz-ul-Basit, Additional Secretary (Committees), Provincial Assembly of the Punjab functioned as Secretary to the Committee.

4. Mr Ehsan Riaz Fatyana, MPA/Mover pointed out that the Punjab Provincial Cooperative Bank Limited was charging 12% mark-up on loan for Industry and 16% mark-up on loan for agriculture.

Whereas, the Punjab Government had announced that the farmers would be extended loan facility on easy installments. Thus farmers were paying heavy interest on loan. The Department submitted that there were huge expenses in Head office of the Punjab Provincial Cooperative Bank Limited and Zonal offices, consequently, the farmers had to bear such heavy interest on loan.

5. The President, Punjab Provincial Cooperative Bank Limited further stated that there were four main lending schemes for the farmers and Punjab Provincial Cooperative Bank Limited was ready to reduce mark-up rate on the subject four main lending schemes in two phases. He submitted the detail as under:-

6. The Mover as well the Committee was satisfied with the explanation and decided to dispose of the subject Starred Question.
