REPORT OF THE STANDING COMMITTEE ON EDUCATION REGARDING MUHAMMAD NAWAZ SHARIF UNIVERSITY OF ENGINEERING AND TECHNOLOGY MULTAN BILL 2014 (BILL NO. 10 OF 2014)

Muhammad Nawaz Sharif University of Engineering and Technology Multan Bill 2014 (Bill No.10 of 2014) was referred to the Standing Committee on Education on 13 March 2014. The Committee considered the bill in its meetings held on 4 and 9 April 2014.

- 3. Mr Abdullah Khan Sumbal, Secretary, Higher Education Department and Mr Mohsin Abbas Syed, Director, Law and Parliamentary Affairs Department represented their Departments. Hafiz Muhammad Shafiq Adil, Acting Secretary, Provincial Assembly of the Punjab functioned as Secretary to the Committee.
- 4. The Committee, after hearing the Members, having the view points of the Administrative Department and discussing various points, unanimously decided to recommend that the bill may be passed by the Assembly subject to the following amendments:-

AMENDMENTS IN THE BILL

- (1) CLAUSE 1 in sub-clause (1), the figures "2013" be substituted by the figures "2014".
- after para (r), the following be added as para (s) and subsequent paras be renumbered accordingly:-
 - "(s) "student" means a student of the University;".

(3) CLAUSE 3

- (i) in sub-clause (2), in para (g), the words "of the University" be omitted; and
- (ii) sub-clause (4) be omitted and sub-clause (5) be re-numbered as sub-clause (4).

 - (b) in para (d), the words "in the prescribed manner" be omitted.

(5) CLAUSE 5

the words "Province of the" be omitted.

(6) CLAUSE 8

(7) CLAUSE 9

(11) CLAUSE 13

(12) CLAUSE 14

- (i) sub-clause (1) be substituted as under:-
 - "(1) The Government shall, on the recommendation of the Syndicate, appoint a Registrar for each term in such manner and on such terms and conditions as may be prescribed.";
- (ii) in sub-clause (2), the word "Syndicate" be substituted by the word "Government"; and
- (ii) in sub-clause (4), the words "a term" be substituted by the words "each term".

(13) CLAUSE 15

- (i) sub-clause (1) be substituted as under:-
 - "(1) The Government shall appoint a Treasurer for each term in such manner and on such terms and conditions as may be prescribed.";

 - "(i) five persons of eminence, including at least one woman, of whom at least two shall be engineers registered with the Pakistan Engineering Council, to be nominated by the Chancellor; and"; and
- (iii) in para (j), the words "in consultation with the Vice Chancellor" be omitted.

(17) CLAUSE 21

- (i) in sub-clause (2)-
 - (a) in para (ii), the words "in this behalf", be omitted;
 - (b) in para (xviii), after the word "degree" the words "on a person of eminence" be added;
 - (c) in para (xxvi), the word "and" be added at the end; and
 - (d) para (xxvii) be omitted and subsequent para be re-numbered accordingly;
- (ii) after sub-clause (2), following new sub-clause (3) be added:-
 - "(3) The Syndicate may delegate any of its functions to an Authority or officer or a committee or sub-committee except the following functions:
 - (a) approval of statutes or recommendation of the drafts of the statutes to the Chancellor;
 - (b) approval of regulations;
 - (c) approval of annual budget of the University, annual report, the annual and revised budget estimates and re-appropriation of funds from one major head of expenditure to another;
 - (d) approval of investment or purchase of immovable property by the University; and
 - (e) transfer of immovable property of the University."

(18) CLAUSE 22

- (i) in sub-clause (1)—
 - (a) in para (g), the word "Chairmen" be substituted by the word "chairpersons";
 - (b) in para (i), after the word "persons" the commas and the words ", including at least one woman, of' be added and the words "social sciences' be substituted by the words "information technology";
 - (c) in para (k), the commas and the words ", Punjab, Lahore" be omitted;
 - (d) in para (l), the commas and the words ", Punjab, Lahore" be omitted; and
 - (e) in para (m), after the word "Librarian", the words "of the University" be added;
- (ii) in sub-clause (2), the word "Members" be substituted by the word "A member":
- (iii) in sub-clause (3), the word "or" be substituted by the word "for" and after the word "members", the comma and the words ", a fraction being counted as one" be added.

(19) CLAUSE 24

in sub-clause (3), after the word "members", the comma and the words ", a fraction being counted as one" be added.

(20) CLAUSE 25

- (i) in sub-clause (1), in para (f), after the word "members", the commas and the words ", including at least one woman," be added; and
- (ii) in sub-clause (3), after the word "members", the comma and the words ", a fraction being counted as one" be added.

(21) CLAUSE 29

in sub-clause (3), the word "Five" be substituted by the word "Six".

(22) CLAUSE 31

the word "committees" be substituted by the word "committee" and the word "also" be substituted by the word "may".

(23) CLAUSE 33

in sub-clause (1)-

- (a) in para (b), figure "7" be substituted by figure "4"; and
- (b) in para (g) and para (h), the words "of the University" be omitted.

(24) CLAUSE 36

in sub-clause (6), the words "Auditor appointed by the Government" be substituted by the words "Resident Auditor".

(25) CLAUSE 38

clause 38 be substituted as under:

- **"38. Tripartite Mobility.** (1) Any officer, teacher of the Government or employee of the University, on the recommendation of the Syndicate, may be directed to serve in any post in the University under the Government or an educational research institution.
- (2) The Government may, in consultation with the Selection Board, place the services of an employee of the Government or of any other University or of an educational or research institution at the disposal of the University in the public interest.
- (3) The terms and conditions offered to a person appointed under this section shall not be less favorable than those enjoyed by him immediately before his services are placed at the disposal of the University, Government or any other institution and full benefit of his previous service shall continue to remain in force until altered in accordance with law.".

(26) CLAUSE 40

the marginal heading, "Transitory Provisions" be substituted by the marginal heading "Transition".

(27) ADDITION OF NEW CLAUSE 43

after clause 42, the following new clause 43 be added:-

- "43. Savings.— Notwithstanding anything contained in this Act, an examination conducted or any act done by the administration of the proposed University prior to the coming into force of the Act, shall be deemed to be the examination conducted or act done by the University under the Act and the University may award degree, diploma or certificate on the basis of such examination."

MUHAMMAD NAWAZ SHARIF UNIVERSITY OF ENGINEERING AND TECHNOLOGY MULTAN BILL 2014

BILL

to provide for the establishment of Muhammad Nawaz Sharif University of Engineering and Technology Multan.

Preamble - Whereas it is expedient to provide for the establishment of Muhammad Nawaz Sharif University of Engineering and Technology Multan and for ancillary matters;

It is enacted as follows:-

CHAPTER I

- 1. Short title and commencement.— (1) This Act may be cited as Muhammad Nawaz Sharif University of Engineering and Technology Multan Act 2013.
 - (2) It shall come into force at once.
- 2. Definitions.- In this Act-
 - (a) "Academic Council" means the Academic Council of the University;
 - (b) "affiliated college" means a college or institute affiliated with the University;
 - (c) "Authority" means an Authority of the University;
 - (d) "chairperson" means the head of an academic department and includes Principal of a constituent college or Director of an institute;
 - (e) "Chancellor" means Chancellor of the University;
 - (f) "Commission" means Higher Education Commission set up under the Higher Education Commission Ordinance, 2002 (LIII of 2002);
 - (g) "constituent college" means a college maintained and administered by the University;
 - (h) "Controller of Examinations" means Controller of Examinations of the University;
 - (i) "Dean" means the head of a faculty of the University;
 - (j) "department" means a teaching, research and technological development department maintained and administered by the University;
 - (k) "faculty" means an administrative and academic unit of the University consisting of one or more departments, institutes or constituent colleges;
 - (I) "Government" means Government of the Punjab;
 - (m) "institute" means an institute established, maintained and administered by the University;
 - (n) "prescribed" means prescribed by the rules, statutes or regulations;
 - (o) "Pro-Chancellor" means Pro-Chancellor of the University;
 - (p) "Pro-Vice Chancellor" means Pro-Vice Chancellor of the University;
 - (q) "Registrar" means Registrar of the University;
 - (r) "statutes", "regulations" and "rules" respectively mean the statutes, regulations and rules made or deemed to have been made under the Act;
 - (s) "Syndicate" means Syndicate of the University;
 - (t) "teacher" includes a Professor, Associate Professor, Assistant Professor or lecturer having prescribed qualifications engaged whole time by the University for teaching diploma, degree or postgraduate classes and engaged in research and development of technologies and such other persons as may be prescribed;
 - (u) "University" means Muhammad Nawaz Sharif University of Engineering and Technology Multan; and
 - (v) "Vice Chancellor" means Vice Chancellor of the University

CHAPTER II THE UNIVERSITY

- 3. Incorporation (1) There shall be a University of Engineering and Technology to be called Muhammad Nawaz Sharif University of Engineering and Technology Multan, with the main campus at Multan and the sub-campus at such other place as the University may establish with the approval of the Government.
 - (2) The University shall consist of the following:-

- (a) Chancellor;
- (b) Pro-Chancellor;
- (c) Vice Chancellor;
- (d) Pro-Vice Chancellor;
- (e) members of an Authority;
- (f) chairpersons and Deans;
- (g) teachers and students of the University; and
- (h) officers and members of the staff of the University.
- (3) The University shall be a body corporate by the name of Muhammad Nawaz Sharif University of Engineering and Technology Multan, and shall have a perpetual succession and a common seal and may, by the said name, sue and be sued.
- (4) The Government may, by notification, affiliate any of its post graduate and degree colleges with the University.
- (5) The University may, with the approval of the Government, open and administer a sub-campus of the University.

4. Functions of the University. - (1) The University shall-

- (a) provide for instructions in such branches of learning as it may deem fit, and to make provisions for teaching, training, research and development of technologies and for the advancement and dissemination of knowledge in engineering and technology and such other fields of study as it may determine;
- (b) prescribe courses of studies;
- (c) hold examinations in the prescribed manner and, if a person qualifies the examination, award degree, diploma, certificate and other academic distinction to the person;
- (d) confer, in the prescribed manner, honorary degrees or other academic distinctions on such persons as the Chancellor may approve on the recommendation of the Syndicate;
- (e) create posts in connection with teaching, research, development of technology, administration, and for any other purpose related thereto and appoint persons against those posts;
- (f) institute and award financial assistance to students in need, fellowships, scholarships, bursaries, medals and prizes in the prescribed manner;
- (g) establish academic departments and faculties for the development of teaching, research and technological development and make such arrangements for their maintenance, management and administration, as it may determine;
- (h) control and maintain University halls of residence for students and approve any place as hostel or lodging for students;
- (i) supervise and control the discipline of students of the University;
- (j) maintain order, discipline and security in a campus of the University;
- (k) take disciplinary action against and impose penalty on students in the prescribed manner;
- (I) charge and receive such fees and other payments as it may determine;
- (m) receive and manage property (acquired or transferred), grants, bequests, trusts, gifts, donations, endowments and other contributions, made to the University, and invest any fund representing such property, grants, bequests, trusts, gifts, donations, endowments or contributions in such manner as it may deem fit;
- (n) provide for the printing and publication of research and other works as prescribed;
- (o) provide facilities for development of prototypes based on research and development and exploit technology singly or in cooperation with such ventures and in such manner as it may deem fit;
- (p) provide career counselling and job search services to the students and alumni;
- (q) promote extracurricular and recreational activities of the students and make arrangements for promoting health and general welfare of the students; and
- (r) perform any other prescribed or ancillary function.

(2) The University may-

(a) institute programmes for the exchange of students and teachers between the University and any other university, educational institution or research organization;

(b) develop and implement fund-raising plans;

(c) accept an examination and the period of study spent by a student of the University at any other university or place of learning equivalent to an examination or period of study of the University and may withdraw such acceptance;

(d) cooperate with a public authority, university or private organization in the prescribed

manner;

 (e) make provision for research, advisory or consultancy services and enter into arrangements with any other institution, public or private body, commercial or industrial enterprise in the prescribed manner;

(f) receive and manage property transferred and grants, contributions made to the University and to invest any fund in the manner as it may deem fit;

(g) print and publish research or work; and

(h) exercise any power ancillary to the above powers or as may be prescribed.

- 5. Jurisdiction of the University.— The jurisdiction of the University shall extend to the Province of the Punjab.
- **6.** University to be open to all classes and creeds.— The University shall be open to all persons irrespective of gender, religion, race, creed, class or colour and no person shall be denied the privileges of the University on any such ground.

CHAPTER III OFFICERS OF THE UNIVERSITY

7. Officers of the University.- The following shall be the officers of the University:-

(a) Chancellor;

- (b) Pro-Chancellor;
- (c) Vice Chancellor:
- (d) Pro-Vice Chancellor;
- (e) Deans:
- (f) Chairpersons:
- (g) Registrar;
- (h) Treasurer;
- (i) Controller of Examinations:
- (j) Resident Auditor; and
- (k) such other persons as may be prescribed.
- 8. Chancellor. (1) Governor of the Punjab shall be the Chancellor of the University.

(2) The University may, subject to prior approval of the Chancellor, confer an honorary degree.

(3) Subject to this Act, the Chancellor may approve the draft statutes submitted by the Syndicate or refer the statutes back to the Syndicate for reconsideration

(4) In the performance of his functions under this Act, the Chancellor shall act and shall be bound in the same manner as the Governor of a Province acts and is bound under Article 105 of the Constitution of the Islamic Republic of Pakistan.

- **9.** Inspection and inquiry.— (1) The Chancellor may direct inspection or inquiry into the affairs of the University.
- (2) The Chancellor shall convey the views with regard to the result of the inspection or inquiry to the Syndicate and may, after ascertaining the views of the Syndicate, recommend any remedial action to the Syndicate.
- (3) The Syndicate shall, within the time specified by the Chancellor, submit report to the Chancellor about the action taken on the recommendation of the Chancellor.

(4) If the Syndicate fails to take action to the satisfaction of the Chancellor within the specified time, the Chancellor may issue such direction as the Chancellor deems appropriate

and the Syndicate shall comply with the direction. (5) The Chancellor may set aside a decision or action of the Syndicate, which, in the opinion of the Chancellor, is against the law, interest of academic excellence of the University, religious or cultural ideology, or national integrity.

10. Pro-Chancellor - (1) Minister for Higher Education of the Government shall be the Pro-

- (2) The Pro-Chancellor shall perform functions under this Act and exercise such powers of Chancellor of the University. the Chancellor, except the powers under section 10, as may be prescribed or assigned to him by the Chancellor.
- 11. Vice Chancellor. (1)A person who is eligible and who is not more than sixty five years of age on the last date fixed for submission of applications for the post of the Vice Chancellor may apply for the post.

(2) The Government shall determine, by notification in the official Gazette, the qualifications,

experience and other relevant requirements for the post of the Vice Chancellor.

(3) The Government shall constitute, for a term of two years, a Search Committee consisting of not less than three and not more than five members for making recommendations for appointment of the Vice Chancellor.

(4) The Search Committee shall follow such procedure and criteria, for selection of the panel for the post of the Vice Chancellor, as the Government may, be notification, determine.

(5) The Search Committee shall recommend to the Government, in the order of merit, a panel of three persons who, in its opinion, or suitable for appointment as the Vice Chancellor.

(6) The Chancellor shall appoint the Vice Chancellor for each term of four years but he shall serve during the pleasure of the Chancellor.

(7) The Government shall determine the terms and conditions of service of the Vice Chancellor.

(8) The incumbent Vice Chancellor shall not be allowed any extension in his tenure but subject to eligibility he may again compete for the post of the Vice Chancellor in accordance

with the procedure prescribed by or under this section.

- (9) If the office of the Vice Chancellor is vacant or the Vice Chancellor is absent or is unable to perform the functions of the Vice chancellor owing to any cause, the Pro-Vice Chancellor shall perform the functions of the Vice Chancellor but, if at any time, the office of Pro-Vice Chancellor is also vacant or the Pro-Vice Chancellor is absent or is unable to perform the functions of the Vice Chancellor owing to any cause, the Chancellor shall make such temporary arrangements for the performance of the duties of the Vice Chancellor as he may deem fit.
- 12. Powers of the Vice Chancellor.- (1) The Vice Chancellor shall be the principal executive and academic officer of the University and shall ensure that the provisions of this Act, statutes, regulations and rules are faithfully observed in order to promote teaching, research, technology development, publications, administration and the general efficiency and good order of the University.

(2) The Vice Chancellor shall preside over the meetings of the Authorities of which he is the Chairman and be entitled to attend and preside over any meeting of any other Authority or body of the

(3) Subject to such conditions a may be prescribed, the Vice Chancellor may, in an University. emergency, take an action which is not otherwise in the competence of the Vice Chancellor but is in the competence of any other Authority.

(4) The Vice Chancellor shall, within seven days of taking an action under subsection (3), submit a report to the members of the Syndicate: and, the Syndicate shall, within forty five days of the action of the Vice Chancellor, pass such orders as it may deem appropriate.

(5) Subject to the general supervision and control of the Syndicate, the Vice Chancellor may-

(a) direct a teacher, officer or other employee of the University to take up such assignment in connection with examination, administration or any other activity in relation to the

(b) sanction by re-appropriation an amount for an unforeseen item not provided for in

the budget of the University;

(c) make appointments of such categories of employees of the University and in such manner as may be prescribed;

(d) take disciplinary action against a teacher, officer or any other employee of the University in the prescribed manner;

(e) delegate, subject to such conditions as may be prescribed, any of his powers to a teacher or officer of the University; and

(f) exercise such other powers as may be prescribed or as may be assigned by the

(6) The Vice Chancellor shall prepare an annual report containing information as regards the preceding academic year including disclosure of all relevant facts pertaining to academics, research, administration and finances of the University.

(7) The Vice Chancellor shall, within three months of the conclusion of an academic year, submit the annual report of the University to the Syndicate.

13. Pro-Vice Chancellor.- (1) The Chancellor shall nominate the Pro-Vice Chancellor of the University, from amongst three senior most Professors of the University, for a term of three years.

(2) A Pro-Vice Chancellor shall perform such functions as may be assigned to him under

this Act, statutes or regulations.

- (3) The Syndicate of the Vice Chancellor may assign any other functions to the Pro-Vice Chancellor in addition to his duties as Professor.
- 14. Registrar.- (1) The Syndicate shall, on the recommendation of the Vice Chancellor, appoint a Registrar in such manner and on such terms and conditions as may be prescribed.

(2) The Syndicate shall not appoint a person as Registrar unless he possesses the prescribed qualifications and experience.

(3) The Registrar shall be a full-time officer of the University and shall-

(a) be the administrative head of the secretariat of the University and be responsible for the provision of secretarial support to the Syndicate and the Vice Chancellor;

(b) be the custodian of the common seal and the academic records of the University;

(c) maintain a register of the students and graduates in the prescribed manner;

(d) supervise the process of election, appointment or nomination of a member to an Authority or body of the University in the prescribed manner, and

(e) perform such other duties as may be prescribed or assigned by the Syndicate.

(4) The Registrar shall hold office for a term of three years.

15. Treasurer - (1) The Syndicate shall, on the recommendation of the Vice Chancellor, appoint a Treasurer in such manner and on such terms and conditions as may be prescribed.

(2) The Syndicate shall not appoint a person as Treasurer unless he possesses the prescribed qualifications and experience.

(3) The Treasurer shall be the chief financial officer of the University and shall-

- (a) manage the assets, liabilities, receipts, expenditures, funds and investments of the
- (b) prepare the annual and revised budget estimates of the University and present the estimates to the Syndicate;

(c) ensure that the funds of the University are spent according to the budget or any other special arrangement;

(d) ensure that the accounts of the University are audited annually and are available for submission to the Syndicate within six months of the end of a financial year; and

(e) perform such other functions as may be prescribed or assigned to him by the Syndicate.

(4) The Treasurer shall hold office for a term of three years.

16. Controller of Examinations.- (1) The Syndicate shall, on the recommendation of the Vice Chancellor, appoint a Controller of Examinations in such manner and on such terms and conditions as may be prescribed.

(2) The Syndicate shall not appoint a person as Controller of Examinations unless he

possesses the prescribed qualifications and experience.

- (3) The Controller of Examinations shall be a full-time officer and shall be responsible for all matters connected with the conduct of examinations and perform such other duties as may be prescribed.
 - (4) The Controller of Examinations shall hold office for a term of three years.

17. Resident Auditor. - (1) The Syndicate shall appoint, on deputation, a Resident Auditor of the University from amongst the panel recommended by the Government.

(2) The University shall request the Government to send a panel of three Government

officers qualified to be appointed as Resident Auditor of the University.

(3) The Resident Auditor shall hold office for a term of three years.

- (4) The Resident Auditor shall perform such functions as are prescribed or as the Syndicate may assign.
- 18. Other officers Subject to the provisions of this Act, the terms and conditions of service and powers and duties of other officers of the University shall be such as may be prescribed.

CHAPTER IV **AUTHORITIES OF THE UNIVERSITY**

19. Authorities of the University .-- (1) The following shall be the Authorities of the University:-

(a) Syndicate;

- (b) Academic Council;
- (c) Boards of Faculties;
- (d) Boards of Studies;
- (e) Selection Board;
- (f) Board of Advanced Studies, Research and Technological Development;

(g) Finance Committee;

(h) Planning and Development Committee; and

(i) such other Authorities as may be prescribed under the statutes.

- (2) The Syndicate may constitute committees consisting of the members of the Syndicate or it may create committees consisting of members of the Syndicate or teachers or officers of the University or a combination of all or any of such persons.
- 20. Syndicate. (1) The Syndicate shall consist of-
 - (a) Vice Chancellor who shall be its Chairman;

(b) Pro-Vice Chancellor;

(c) three members of the Provincial Assembly of the Punjab to be nominated by the Speaker of the Punjab;

(d) Secretary to the Government, Higher Education Department or his nominee not below

the rank of Additional Secretary;

(e) Secretary to the Government, Finance Department or his nominee not below the rank of Additional Secretary;

(f) Chairman, Higher Education Commission or his nominee not below the rank of a wholetime Member of the Commission;

(g) Chairman, Pakistan Engineering Council or his nominee not below the rank of a whole-

(h) one vice chancellor of any University of Engineering and Technology in the country to be nominated by the Chancellor;

(i) five persons of eminence, of which at least two shall be such as are registered with the Pakistan Engineering Council, to be nominated by the Chancellor; and

(j) two Deans to be nominated by the Chancellor in consultation with the Vice Chancellor.

(2) The Registrar will be the Secretary of the Syndicate.

(3) The members of the Syndicate, other than ex-officio members, shall be appointed for three years but they shall serve during the pleasure of the Chancellor.

(4) The quorum for a meeting of the Syndicate shall be one half of the total number of

members, a fraction being counted as one.

21. Powers and duties of the Syndicate. - (1) The Syndicate shall be the executive body of the University and shall, subject to the provisions of this Act and the statutes, take effective measures to raise the standard of teaching, research, technological development, publication and other academic pursuits and exercise general supervision over the affairs of the University and management of the property of the University.

(2) Without prejudice to the generality of the foregoing powers and subject to the provisions of the Act, the Syndicate may-

hold, control and administer the property and funds of the University; (i)

govern and regulate, with due regard to the advice of the Finance and Planning (ii) Committee in this behalf, the finances, accounts and investments of the University and for that purpose, to appoint such agents as it may deem fit; (iii)

consider and approve the annual report, the annual and revised budget estimates

and to re-appropriate funds from one major head of expenditure to another; (iv)

transfer and accept transfer of movable or immovable property on behalf of the (V)

enter into, vary, carry out or cancel contracts on behalf of the University;

cause proper books of account to be kept for all sums of money received and (vi) expended by the University and for the assets and liabilities of the University,

(vii) invest any money belonging to the University including any unapplied income inany c: the securities described in section 20 of the Trusts Act 1882 (II of 1882), or in the purchase of immovable property or in such other manner, as it may determine, with the like power of varying such investments;

(viii) receive and manage any property transferred, grants, bequests, trusts, gifts,

donations, endowments and other contributions made to the University;

(ix) determine the form, custody and regulation of the use of the common seal of the (x)

provide buildings, libraries, premises, furniture, apparatus, equipment and other means required for carrying out the work of the University;

establish and maintain halls of residence and hostels or approve or license hostels (xi)

or lodgings for the residence of students; affiliate or disaffiliate colleges and institutes; (xii)

admit educational institutions to the privileges of the University and withdraw (xiii) (xiv)

arrange for the inspection of the academic departments;

institute Professorships, Associate Professorships, Assistant Professorships, (XV) Lecturerships and other posts and to suspend or abolish such posts; (xvi)

create, suspend or abolish such auministrative, technical, research, extension or other posts as may be necessary:

appoint University teachers and other officers on the recommendation of the (xvii) Selection Board for teaching and other managerial posts;

confer, with prior approval of the Chancellor, an honorary degree; (xviii)

prescribe the duties of the officers, teachers and other employees of the (xix) University and of those working in the University on deputation or on contract;

appoint members to the various Authorities, committees and bodies in the (xx)

prescribed manner:

remove any person from the membership of any Authority if such person has (ixxi) accepted any assignment which involves absence from the University for a continuous period of six months or more;

regulate, determine and administer, all other matters concerning the University (iixx) and to this end exercise all necessary powers not specifically mentioned in this

Act and statutes but not inconsistent with the provisions of the Act;

appoint Professor Emeritus on such terms and conditions as may be prescribed; (iiixx)

suspend, punish and remove from service in the prescribed manner officers, (xxiv) teachers and employees whom it is empowered to appoint;

consider and approve regulations recommended by the Academic Council; (XXV)

approve statutes and recommend those drafts of the statutes, for approval of the (xxxvi) Chancellor, which pertain to terms and conditions of service of the University employees;

(xxvii) delegate any of its powers to an Authority or officer or a committee or sub-

committee; and

(xxviii) perform such other functions as may be assigned to it under the Act and the statutes.

22. Academic Council. - (1) The Academic Council shall consist of-

(a) Vice Chancellor (Chairman);

(b) Pro-Vice Chancellor;

(c) Deans:

(d) Director of Advanced Studies, Research and Technological Development;

(e) two senior most Professors, other than ex-officio members, from each academic department;

(f) all Professors Emeritus;

(g) Chairmen of the academic departments:

(h) four University teachers, other than Professors, two from each category of Associate professors and Assistant Professors, to be appointed by the Syndicate;

- (i) three persons eminence in sciences, social sciences and engineering, of whom one shall be from each category, to be nominated by the Chancellor in consultation with the Vice-Chancellor;
- (j) Secretary to Government, Higher Education Department or his nominee not below the rank of Deputy Secretary;

(k) Director Public Instruction (Colleges), Punjab, Lahore;

(I) Director, Technical Education, Punjab, Lahore:

(m) Librarian;

(n) Controller of Examinations;

(o) five experts in the field of education to be nominated by the Chancellor; and

(p) Registrar (Member/Secretary).

(2) Members of the Academic Council appointed by nomination shall hold office for three

(3) The quorum or a meeting of the Academic Council shall be one-third of the total number

of members.

23. Powers and duties of the Academic Council.- (1) The Academic Council shall be the academic body of the University and may lay down proper standards of instruction, research,

publication and examination and to regulate and promote the academic life of the University and affiliated colleges.

(2) In particular and without prejudice to the generality of the foregoing provision, the Academic Council may-

advise the Syndicate on academic matters;

(ii) regulate teaching, research and examinations;

(iii) regulate the admission of students to the courses of studies and examinations of the University and affiliated colleges;

(iv) regulate the award of studentships, scholarships, medals and prizes;

- (v) regulate the conduct and discipline of students of the University and affiliated colleges:
- (vi) propose to the Syndicate schemes for the constitution and organization of faculties, institutes and other academic bodies;

(vii) propose regulations on the recommendations of the Boards of Faculties and the Boards of Studies for consideration and approval of the Syndicate;

(viii) propose for each academic year, on the recommendations of the Boards of Studies, regulations prescribing the courses of studies, the syllabi and the outlines of tests for all examinations; provided that, if the recommendations of a Board of Faculties or the Board of Studies are not received by the prescribed date, the Academic Council may, subject to the approval of the Syndicate, permit such regulations to continue for the following years:

(ix) recognize the examinations of other Universities or examining bodies as equivalent to the corresponding examinations of the University;

(x) appoint members to the Authorities in accordance with the provisions of this Act; and

- (xi) perform such other functions as may be prescribed by the statutes or assigned by the Syndicate.
- 24. Board of Faculty.- (1) There shall be a Board of Faculty for each faculty which shall consist of-

(a) Dean of the faculty (Chairperson);

(b) Professors and the chairpersons in the faculty,

(c) two teachers to be nominated by the Academic Council on the basis of their specialized knowledge of the subjects which, though not assigned to the faculty, have in the opinion of the Academic Council, important bearing on the subjects assigned to the faculty;

(d) two experts in the field from outside the University to be appointed by the Syndicate; and

(e) one member to be nominated by the Vice Chancellor.

(2) The members other than ex-officio members of a Board of faculty shall hold office for a period of three years.

(3) The quorum for a meeting of a Board of faculty shall be one half of the total number of members.

(4) A Board of faculty, subject to the general control of the Syndicate and Academic Council, may-

(a) co-ordinate the teaching and research work in the subjects assigned to the faculty;

(b) scrutinize the recommendations of a Board of Studies comprising a faculty with regard to the appointment of paper setters and examiners for graduate and postgraduate examinations and to forward the panels of suitable paper setters and examiners for each examination to the Vice Chancellor;

(c) consider any other academic matter relating to the faculty and to submit its report to the Academic Council;

- (d) prepare a comprehensive annual report regarding the performance of each department, constituent college or Institute comprising the faculty for presentation to the Academic Council; and
- (e) perform such other functions as may be prescribed by statutes.

25. Board of Advanced Studies and Research.— (1) The Board of Advanced Studies and Research shall consist of—

(a) Vice Chancellor (Chairperson);

(b) all the Deans;

(c) Controller of Examinations:

(d) one University Professor from each faculty to be nominated by the Syndicate;

(e) one member to be nominated by the Vice Chancellor;

(f) three members from the relevant field, research organizations and Government, to be nominated by the Syndicate; and

(g) Registrar (Secretary).

(2) The term of office of the members of the Board of Advanced Studies and Research, other than ex-officio members, shall be three years.

(3) The quorum for a meeting of the Board of Advanced Studies and Research shall be one half of the total number of members.

26. Functions of the Board of Advanced Studies and Research.— The Board of Advanced Studies and Research shall—

- (a) advise an Authority on all matters connected with the promotion of advanced studies and research publication in the University;
- (b) consider and report to an Authority with regard to a research degree of the University;

(c) propose regulations regarding the award of a research degree;

- (d) appoint supervisors for a postgraduate research student and to approve title and synopsis of a thesis or dissertation;
- (e) recommend panels of names of examiners for evaluation of a research examination; and

(f) perform such other functions as may be prescribed by the statutes.

27. Selection Board. - (1) The Selection Board shall consist of-

(a) Vice Chancellor (Chairperson);

(b) Dean of the faculty concerned;

(c) chairperson concerned;

- (d) one member of the Syndicate to be nominated by the Syndicate;
- (e) one eminent scholar to be nominated by the Syndicate;
- (f) two experts to be nominated by the Government; and

(g) Registrar (Secretary).

(2) The members, other than ex-officio members, shall hold office for a period of three years.

- (3) Five members including at least one expert shall constitute the quorum for a meeting of the Selection Board.
- (4) No member who is a candidate or whose family member is a candidate, for a post to which appointment is to be made, shall take part in the proceedings of the Selection Board for selection of a candidate on such post.
- (5) In selection of candidates for the post of Professor or Associate Professor, the Selection Board shall co-opt or consult three experts in the subject and in selecting candidates for any other teaching post, two experts in the subject, to be nominated by the Vice Chancellor from a standing list of experts for each subject approved by the Syndicate.

(6) The Syndicate may approve or revise the standing list of experts of a subject on the recommendation of the Selection Board.

28. Functions of the Selection Board - The Selection Board shall-

- (a) consider the applications and recommend to the Syndicate, the names of suitable candidates for appointment to feaching and other posts and recommend suitable salary for the selected candidate; and
- (b) consider all cases of promotion or selection of officers of the University and recommend the names of suitable candidates for such promotion or selection to the Syndicate.

29. Finance and Planning Committee. - (1) The Finance and Planning Committee shall consist of-

(b) all the Deans;

(c) one member of the Syndicate to be nominated by the Syndicate;

(d) one member of the Academic Council to be nominated by the Academic Council;

(e) one representative each from Higher Education Department and Finance Department of the Government not below the rank of a Deputy Secretary;

(f) Director Planning or any other nominee of the Commission;

(g) Registrar; and

(h) Treasurer (Secretary).

(2) The term of office of the nominated members shall be three years.

- (3) Five members of the Finance and Planning Committee shall constitute the quorum for a meeting of the Finance and Planning Committee.
- 30. Functions of the Finance and Planning Committee. The Finance and Planning
 - (a) prepare the annual statement of accounts and propose annual budget estimates and make recommendations to the Syndicate;

(b) review periodically the financial position of the University;

- (c) advise the Syndicate on all matters relating to finance, investments and accounts of the
- (d) perform such other functions as may be prescribed by the statutes.
- 31. Appointment of Committees by Authorities -- Any Authority may constitute such standing, special or advisory committees as it may deem fit, and also appoint on such committees such

CHAPTER V STATUTES, REGULATIONS AND RULES

32. Statutes.- (1) Subject to the provisions of this Act, the Syndicate may make statutes or recommend statutes relating to the matters specified in clauses (i) and (ii) of sub-section (2) to

(2) The statutes may be made to provide for and regulate all or any of the following matters:-

scales of pay, method of recruitment and other terms and conditions of service of officers, teachers and other employees of the University and the constitution of their pension, insurance, gratuity, provident fund and benevolent fund;

(ii) conduct and discipline of the officers, teachers and other employees of the

(iii) constitution, powers and duties of the Authorities and conduct of elections to such Authorities and related matters;

(iv) affiliation and disaffiliation of colleges, institutes, etc. and related matters;

- (v) admission of educational institutions to the privileges of the University and the withdrawal of such privileges;
- (vi) establishment of institutes, faculties colleges, departments and academic divisions;

(vii) powers and duties of officers, teachers and employees of the University; (viii) conditions for appointment of Professors Emeritus;

(ix) conditions on which the University may enter into arrangements with public bodies or other organizations for purposes of research and advisory services;

(x) general scheme of studies including the duration of courses, the system of examinations and the number of subjects and papers for examinations;

(xi) award of honorary degrees;

(xii) maintenance of register of students and registered graduates;

(xiii) conduct of elections for membership of Authorities of the University and related matters; and

(xiv) all other matters which are to be prescribed or regulated by the statutes.

- (3) The Syndicate shall recommend statutes under clauses (i) and (ii) of subsection (2) to the Chancellor who may approve it with or without any modification or may refer it back to the Syndicate for reconsideration or may reject it.
- 33. Regulations.— (1) Subject to the provisions of this Act and the statutes, regulations may be made for any of the following matters:-

(a) courses of study for degrees, diplomas and certificates of the University;

(b) manner in which the recognized teaching referred to in subsection (1) of section 7 shall be organized and conducted;

(c) admission of students to the University;

(d) conditions under which students shall be admitted to the courses and examinations of the University and shall become eligible for the award of degrees, diplomas and certificates;

(e) conduct of examinations;

(f) fees and other charges to be paid by the students for admission to the courses of study and the examinations of the University;

(g) conduct and discipline of students of the University;

(h) conditions of residence of the students of the University including the levying of fees for residence in halls of residence and hostels;

(i) approval and licensing of hostels and lodgings;

(j) conditions under which a person should conduct research to entitle him to a degree;

(k) institution of fellowships, scholarships, exhibitions, medals and prizes;

(I) institution of stipends and free and half-free studentship;

(m) academic costumes;

(n) use of the library; and

(o) establishment of academic departments.

- (2) The Academic Council shall prepare and submit the regulations to the Syndicate and the Syndicate may approve them with or without modifications or refer them back to the Academic Council for reconsideration or reject them.
- **34.** Rules.— (1) An Authority or a body of the University may make rules consistent with this Act, statutes and regulations, to regulate the conduct of its business.

(2) The Syndicate may direct any Authority or body of the University to amend or repeal any rules made by the Authority or body.

CHAPTER VI UNIVERSITY FUND

35. University Fund.—(1) The University shall have a fund to which shall be credited its income from fees, donations, trusts, bequests, endowments, contributions, grants and all other sources.

- (2) The University may accept donations in the shape of land, vehicles, equipment or any other items that may facilitate the functioning of the University and all such donations shall be used, maintained and disposed of by the University in the prescribed manner.
- **36. Budget, Audit and accounts.** (1) The accounts of the University shall be maintained in such form and in such manner as may be prescribed.
- (2) No expenditure shall be made from the University Fund unless a bill for payment has in the prescribed manner, been audited by the Resident Auditor in conformity with the Statutes, Regulations and Rules.
- (3) The accounts of the University shall be sudited in the prescribed manner once a year by an auditor appointed by the Government in this behalf.

(4) The Syndicate may delegate the power of appropriation or re-appropriation of funds to

an officer of the University.

(5) The annual statement of accounts of the University signed by the Treasurer and the Resident Auditor shall be submitted to the Government within six months of the closing of the financial year.

(6) The accounts of the University together with audit objections, if any, and the observations of the Auditor appointed by the Government and the Treasurer shall, in the prescribed manner, be

presented to the Syndicate with the remarks of the Finance and Planning Committee.

CHAPTER VII **MISCELLANEOUS**

37. Appeal to Syndicate. - (1) If an order is passed by an Authority, body or officer of the University, other than the Chancellor, and an appeal against the order is not provided under the statutes or the regulations, any aggrieved person may prefer an appeal against the order to the Syndicate.

(2) The Syndicate may constitute a committee of its members to hear and dispose of any

appeal on behalf of the Syndicate.

- (3) If a member of the Syndicate is the officer who passed the order or who is also member of the Authority against whose order appeal is filed before the Syndicate, such member shall not hear the appeal as member of the Syndicate or committee constituted to hear and dispose of the appeal.
- 38. Tripartite Mobility.- (1) Any officer, teacher of the Government or employee of the University on the recommendation of the Syndicate may be directed to serve in any post in the University under the Government or an educational research institution in the public interest:

Provided that the terms and conditions offered to him shall not be less favorable than those enjoyed by him immediately before his services are placed at the disposal of the University, and full benefit of his previous service shall continue to remain in force until amended or repealed.

(2) The Government may, in consultation with the Selection Board place the services of an employee of the Government or any other University or an educational or research institution at

the disposal of the University in the public interest:

Provided that the terms and conditions offered to him shall not be less favorable than those enjoyed by him immediately before his services are placed at the disposal of the University and that full benefit of his previous service shall be allowed to him.

- 39. Proceedings of Authorities not invalidated by vacancies. No act, proceeding, resolution or decision of any Authority shall be invalid by reason only of the existence of any vacancy in, or any defect in the constitution of, the Authority.
- 40. Transitory Provisions. A Chancellor's Committee shall be constituted by the Chancellor on the recommendations of the Government to exercise the powers assigned to the Syndicate under this Act till such time the Syndicate is constituted in accordance with the provisions of this Act.
- 41. Removal of difficulties. If any difficulty arises in giving effect to any of the provisions of this Act, the Government may give such directions, not inconsistent with the Act, as it may consider necessary for the removal of such difficulty.
- 42. Indemnity -- No suit or legal proceedings shall lie against the Government, the University or any Authority, officer or employee of the Government or the University or any person in respect of anything which is done in good faith under this Act.

A Bill

to provide for the establishment of Muhammad Nawaz Sharif University of Engineering and Technology Multan.

Preamble.— Whereas it is expedient to provide for the establishment of Muhammad Nawaz Sharif University of Engineering and Technology Multan and for ancillary matters;

It is enacted as follows:-

CHAPTER I PRELIMINARY

- 1. Short title and commencement.— (1) This Act may be cited as Muhammad Nawaz Sharif University of Engineering and Technology Multan Act 2014.
 - (2) It shall come into force at once.
- 2. Definitions.- In this Act-
 - (a) "Academic Council" means the Academic Council of the University;
 - (b) "affiliated college" means a college or institute affiliated with the University;
 - (c) "Authority" means an Authority of the University;
 - (d) "chairperson" means the head of an academic department and includes Principal of a constituent college or Director of an institute;
 - (e) "Chancellor" means Chancellor of the University;
 - (f) "Commission" means Higher Education Commission set up under the Higher Education Commission Ordinance, 2002 (LIII of 2002);
 - (g) "constituent college" means a college maintained and administered by the University;
 - (h) "Controller of Examinations" means Controller of Examinations of the University;
 - (i) "Dean" means the head of a faculty of the University;
 - (j) "department" means a teaching, research and technological development department maintained and administered by the University;
 - (k) "faculty" means an administrative and academic unit of the University consisting of one or more departments, institutes or constituent colleges;
 - (I) "Government" means Government of the Punjab;
 - (m) "institute" means an institute established, maintained and administered by the University;
 - (n) "prescribed" means prescribed by the rules, statutes or regulations;
 - (o) "Pro-Chancellor" means Pro-Chancellor of the University;
 - (p) "Pro-Vice Chancellor" means Pro-Vice Chancellor of the University;
 - (q) "Registrar" means Registrar of the University;
 - (r) "statutes", "regulations" and "rules" respectively mean the statutes, regulations and rules made or deemed to have been made under the Act;
 - (s) "student" means a student of the University;
 - (t) "Syndicate" means Syndicate of the University;
 - (u) "teacher" includes a Professor, Associate Professor, Assistant Professor or lecturer having prescribed qualifications engaged whole time by the University for teaching diploma, degree or postgraduate classes and engaged in research and development of technologies and such other persons as may be prescribed;
 - (v) "University" means Muhammad Nawaz Sharif University of Engineering and Technology Multan; and
 - (w) "Vice Chancellor" means Vice Chancellor of the University.

CHAPTER II THE UNIVERSITY

- 3. Incorporation.— (1) There shall be a University of Engineering and Technology to be called Muhammad Nawaz Sharif University of Engineering and Technology Multan, with the main campus at Multan and the sub-campus at such other place as the University may establish with the approval of the Government.
 - (2) The University shall consist of the following:-
 - (a) Chancellor;
 - (b) Pro-Chancellor:
 - (c) Vice Chancellor;
 - (d) Pro-Vice Chancellor;
 - (e) members of an Authority;
 - (f) chairpersons and Deans;
 - (g) teachers and students; and
 - (h) officers and members of the staff of the University.
- (3) The University shall be a body corporate by the name of Muhammad Nawaz Sharif University of Engineering and Technology Multan, and shall have a perpetual succession and a common seal and may, by the said name, sue and be sued.
- (4) The University may, with the approval of the Government, open and administer a subcampus of the University.

4. Functions of the University. – (1) The University shall–

- (a) provide for instructions in such branches of learning as it may deem fit, and to make provisions for teaching, training, research and development of technologies and for the advancement and dissemination of knowledge in engineering and technology and such other fields of study as it may determine;
- (b) prescribe courses of studies;
- (c) hold examinations in the prescribed manner and, if a person qualifies the examination, award degree, diploma, certificate and other academic distinction to the person;
- (d) confer, in the prescribed manner, honorary degree or other academic distinction on a person of eminence as the Chancellor may approve on the recommendation of the Syndicate:
- (e) create posts in connection with teaching, research, development of technology, administration, and for any other purpose related thereto and appoint persons against those posts;
- (f) institute and award financial assistance to students in need, fellowships, scholarships, bursaries, medals and prizes in the prescribed manner;
- (g) establish academic departments and faculties for the development of teaching, research and technological development and make such arrangements for their maintenance, management and administration, as it may determine;
- (h) control and maintain University halls of residence for students and approve any place as hostel or lodging for students;
- (i) supervise and control the discipline of students;
- (j) maintain order, discipline and security in a campus of the University;
- (k) take disciplinary action against and impose penalty on students in the prescribed manner;
- (I) charge and receive such fees and other payments as it may determine;
- (m) receive and manage property (acquired or transferred), grants, bequests, trusts, gifts, donations, endowments and other contributions, made to the University, and invest any fund representing such property, grants, bequests, trusts, gifts, donations, endowments or contributions in such manner as it may deem fit;
- (n) provide for the printing and publication of research and other works as prescribed;

- (o) provide facilities for development of prototypes based on research and development and exploit technology singly or in cooperation with such ventures and in such manner as it may deem fit;
- (p) provide career counselling and job search services to the students and alumni;
- (q) promote extracurricular and recreational activities of the students and make arrangements for promoting health and general welfare of the students; and
- (r) perform any other prescribed or ancillary function.
- (2) The University may-
 - (a) institute programmes for the exchange of students and teachers between the University and any other university, educational institution or research organization,
 - (b) develop and implement fund-raising plans;
 - (c) accept an examination and the period of study spent by a student at any other university or place of learning equivalent to an examination or period of study of the University and may withdraw such acceptance;
 - (d) cooperate with a public authority, university or private organization;
 - (e) make provision for research, advisory or consultancy services and enter into arrangements with any other institution, public or private body, commercial or industrial enterprise in the prescribed manner;
 - (f) receive and manage property transferred and grants, contributions made to the University and to invest any fund in the manner as it may deem fit;
 - (g) print and publish research or work; and
 - (h) exercise any power ancillary to the above powers or as may be prescribed.
- **5. Jurisdiction of the University.** The jurisdiction of the University shall extend to the Punjab.
- **6.** University to be open to all classes and creeds.~ The University shall be open to all persons irrespective of gender, religion, race, creed, class or colour and no person shall be denied the privileges of the University on any such ground.

CHAPTER III OFFICERS OF THE UNIVERSITY

- 7. Officers of the University. The following shall be the officers of the University:-
 - (a) Chancellor;
 - (b) Pro-Chancellor;
 - (c) Vice Chancellor;
 - (d) Pro-Vice Chancellor;
 - (e) Deans;
 - (f) Chairpersons;
 - (g) Registrar;
 - (h) Treasurer;
 - (i) Controller of Examinations;
 - (i) Resident Auditor; and
 - (k) such other persons as may be prescribed.
- 8. Chancellor. (1) Governor of the Punjab shall be the Chancellor of the University.
- (2) The University may, subject to prior approval of the Chancellor, confer an honorary degree on a person of eminence.
- (3) Subject to this Act, the Chancellor may approve the draft statutes submitted by the Syndicate or refer the statutes back to the Syndicate for reconsideration

- (4) In the performance of his functions under this Act, the Chancellor shall act and shall be bound in the same manner as the Governor of a Province acts and is bound under Article 105 of the Constitution of the Islamic Republic of Pakistan.
- 9. Inspection and inquiry.— (1) The Chancellor may direct inspection or inquiry into the affairs of the University.
- (2) The Chancellor shall convey the views with regard to the result of the inspection or inquiry to the Syndicate and may, after ascertaining the views of the Syndicate, <u>direct</u> any remedial action to the Syndicate.
- (3) The Syndicate shall, within the time specified by the Chancellor, submit <u>compliance</u> report to the Chancellor about the action taken on the <u>direction</u> of the Chancellor.
- (4) If the Syndicate fails to take action to the satisfaction of the Chancellor within the specified time, the Chancellor may issue such direction as the Chancellor deems appropriate and the Syndicate shall comply with the direction.
- (5) The Chancellor may set aside a decision or action of the Syndicate, which, in the opinion of the Chancellor, is against the law, interest of academic excellence of the University, religious or cultural ideology, or national integrity.
- **10. Pro-Chancellor.** (1) Minister for Higher Education of the Government shall be the Pro-Chancellor of the University.
- (2) The Pro-Chancellor shall perform functions under this Act and exercise such powers of the Chancellor, except the powers under section $\underline{9}$, as may be prescribed or assigned to him by the Chancellor.
- **11. Vice Chancellor.** (1) A person who is eligible and who is not more than sixty five years of age on the last date fixed for submission of applications for the post of the Vice Chancellor may apply for the post.
- (2) The Government shall determine, by notification in the official Gazette, the qualifications, experience and other relevant requirements for the post of the Vice Chancellor.
- (3) The Government shall constitute, for a term of two years, a Search Committee consisting of not less than three and not more than five members for making recommendations for appointment of the Vice Chancellor.
- (4) The Search Committee shall follow such procedure and criteria, for selection of the panel for the post of the Vice Chancellor, as the Government may, by notification, determine.
- (5) The Search Committee shall recommend to the Government, in the order of merit, a panel of three persons who, in its opinion, <u>are</u> suitable for appointment as the Vice Chancellor.
- (6) The Chancellor shall appoint the Vice Chancellor for each term of four years but he shall serve during the pleasure of the Chancellor.
- (7) The Government shall determine the terms and conditions of service of the Vice Chancellor.
- (8) The incumbent Vice Chancellor shall not be allowed any extension in his tenure but subject to eligibility he may again compete for the post of the Vice Chancellor in accordance with the procedure prescribed under this section.
- (9) If the office of the Vice Chancellor is vacant or the Vice Chancellor is absent or is unable to perform the functions of the Vice chancellor owing to any cause, the Pro-Vice Chancellor shall perform the functions of the Vice Chancellor but, if at any time, the office of Pro-Vice Chancellor is also vacant or the Pro-Vice Chancellor is absent or is unable to perform the functions of the Vice Chancellor owing to any cause, the Chancellor shall make such temporary arrangements for the performance of the duties of the Vice Chancellor as he may deem fit.
- **12.** Powers of the Vice Chancellor (1) The Vice Chancellor shall be the principal executive and academic officer of the University and shall ensure that the provisions of this Act, statutes, regulations

and rules are faithfully observed in order to promote teaching, research, technology development, publications, administration and the general efficiency and good order of the University.

(2) The Vice Chancellor shall preside over the meetings of the Authorities of which he is the Chairman and be entitled to attend and preside over any meeting of any other Authority or body of the University.

(3) Subject to such conditions <u>as</u> may be prescribed, the Vice Chancellor may, in an emergency, take an action which is not otherwise in the competence of the Vice Chancellor but is in the competence of any other Authority.

(4) The Vice Chancellor shall, within seven days of taking an action under subsection (3), submit a report to the members of the Syndicate; and, the Syndicate shall, within forty five days of the action of the Vice Chancellor, pass such orders as it may deem appropriate.

(5) Subject to the general supervision and control of the Syndicate, the Vice Chancellor may-

- (a) direct a teacher, officer or other employee of the University to take up such assignment in connection with examination, administration or any other activity in relation to the University;
- (b) sanction by re-appropriation an amount for an unforeseen item not provided for in the budget of the University;
- (c) make appointments of <u>employees of the University in BS-16 or below</u> and in such manner as may be prescribed;
- (d) take disciplinary action against a teacher, officer or any other employee of the University in the prescribed manner;
- (e) delegate, subject to such conditions as may be prescribed, any of his powers to a teacher or officer of the University; and
- (f) exercise such other powers as may be prescribed or as may be assigned by the Syndicate.
- (6) The Vice Chancellor shall prepare an annual report containing information as regards the preceding academic year including disclosure of all relevant facts pertaining to academics, research, administration and finances of the University.
- (7) The Vice Chancellor shall, within three months of the conclusion of an academic year, submit the annual report of the University to the Syndicate.
- **13. Pro-Vice Chancellor.** (1) The Chancellor shall nominate the Pro-Vice Chancellor of the University, from amongst three senior most Professors of the University, for a term of three years.
- (2) A Pro-Vice Chancellor shall perform such functions as may be assigned to him under this Act, statutes or regulations.
- (3) The Syndicate <u>or</u> the Vice Chancellor may assign any other functions to the Pro-Vice Chancellor in addition to his duties as Professor.
- 14. Registrar. (1) The Government shall, on the recommendation of the Syndicate, appoint a Registrar for each term in such manner and on such terms and conditions as may be prescribed.
- (2) The <u>Government</u> shall not appoint a person as Registrar unless he possesses the prescribed qualifications and experience.
 - (3) The Registrar shall be a full-time officer of the University and shall-
 - (a) be the administrative head of the secretariat of the University and be responsible for the provision of secretarial support to the Syndicate and the Vice Chancellor;
 - (b) be the custodian of the common seal and the academic records of the University;
 - (c) maintain a register of the students and graduates in the prescribed manner;
 - (d) supervise the process of election, appointment or nomination of a member to an Authority or body of the University in the prescribed manner; and
 - (e) perform such other duties as may be prescribed or assigned by the Syndicate.
 - (4) The Registrar shall hold office for each term of three years.

- 15. Treasurer. (1) The Government shall appoint a Treasurer for each term in such manner and on such terms and conditions as may be prescribed.
- (2) The <u>Government</u> shall not appoint a person as Treasurer unless he possesses the prescribed qualifications and experience.
 - (3) The Treasurer shall be the chief financial officer of the University and shall-
 - (a) manage the assets, liabilities, receipts, expenditures, funds and investments of the University;
 - (b) prepare the annual and revised budget estimates of the University and present the estimates to the Syndicate;
 - (c) ensure that the funds of the University are spent according to the budget or any other special arrangement;
 - (d) ensure that the accounts of the University are audited annually and are available for submission to the Syndicate within six months of the end of a financial year; and
 - (e) perform such other functions as may be prescribed or assigned to him by the Syndicate.
 - (4) The Treasurer shall hold office for each term of three years.
- **16. Controller of Examinations.** (1) The <u>Government</u> shall, on the recommendation of the Vice Chancellor, appoint a Controller of Examinations in such manner and on such terms and conditions as may be prescribed.
- (2) The <u>Government</u> shall not appoint a person as Controller of Examinations unless he possesses the prescribed qualifications and experience.
- (3) The Controller of Examinations shall be a full-time officer and shall be responsible for all matters connected with the conduct of examinations and perform such other duties as may be prescribed.
 - (4) The Controller of Examinations shall hold office for each term of three years.
- **17. Resident Auditor.** (1) The Syndicate shall appoint, on deputation, a Resident Auditor of the University from amongst the panel recommended by the Government.
- (2) The University shall request the Government to send a panel of three Government officers qualified to be appointed as Resident Auditor of the University.
 - (3) The Resident Auditor shall hold office for each term of three years.
- (4) The Resident Auditor shall perform such functions as are prescribed or as the Syndicate may assign.
- **18. Other officers.** Subject to the provisions of this Act, the terms and conditions of service and powers and duties of other officers of the University shall be such as may be prescribed.

CHAPTER IV AUTHORITIES OF THE UNIVERSITY

- 19. Authorities of the University.- (1) The following shall be the Authorities of the University:-
 - (a) Syndicate;
 - (b) Academic Council;
 - (c) Boards of Faculties;
 - (d) Boards of Studies;
 - (e) Selection Board;
 - (f) Board of Advanced Studies, Research and Technological Development;
 - (g) Finance Committee;
 - (h) Planning and Development Committee; and
 - (i) such other Authorities as may be prescribed under the statutes.
- (2) The Syndicate may constitute committees consisting of the members of the Syndicate or it may create committees consisting of members of the Syndicate or teachers or officers of the University or a combination of all or any of such persons.

20. Syndicate. - (1) The Syndicate shall consist of-

- (a) Vice Chancellor who shall be its Chairman:
- (b) Pro-Vice Chancellor;
- (c) three members, including at least one woman member, of the Provincial Assembly of the Punjab to be nominated by the Speaker of the Assembly;
- (d) Secretary to the Government, Higher Education Department or his nominee not below the rank of Additional Secretary;
- (e) Secretary to the Government, Finance Department or his nominee not below the rank of Additional Secretary;
- (f) Chairman, Higher Education Commission or his nominee not below the rank of a whole-time Member of the Commission;
- (g) Chairman, Pakistan Engineering Council or his nominee not below the rank of a whole-time Member of the Council;
- (h) one vice chancellor of any University of Engineering and Technology in the country to be nominated by the Chancellor;
- (i) five persons of eminence, including at least one woman, of whom at least two shall be engineers registered with the Pakistan Engineering Council, to be nominated by the Chancellor; and
- (j) two Deans to be nominated by the Chancellor.
- (2) The Registrar will be the Secretary of the Syndicate.
- (3) The members of the Syndicate, other than *ex-officio* members, shall be appointed for three years but they shall serve during the pleasure of the Chancellor.
- (4) The quorum for a meeting of the Syndicate shall be one half of the total number of members, a fraction being counted as one.
- **21.** Powers and duties of the Syndicate.— (1) The Syndicate shall be the executive body of the University and shall, subject to the provisions of this Act and the statutes, take effective measures to raise the standard of teaching, research, technological development, publication and other academic pursuits and exercise general supervision over the affairs of the University and management of the property of the University.
- (2) Without prejudice to the generality of the foregoing powers and subject to the provisions of the Act, the Syndicate may-
 - (i) hold, control and administer the property and funds of the University;
 - govern and regulate, with due regard to the advice of the Finance and Planning Committee, the finances, accounts and investments of the University and for that purpose, to appoint such agents as it may deem fit;
 - (iii) consider and approve the annual report, the annual and revised budget estimates and to re-appropriate funds from one major head of expenditure to another;
 - (iv) transfer and accept transfer of movable or immovable property on behalf of the University;
 - (v) enter into, vary, carry out or cancel contracts on behalf of the University;
 - (vi) cause proper books of account to be kept for all sums of money received and expended by the University and for the assets and liabilities of the University;
 - (vii) invest any money belonging to the University including any unapplied income in any of the securities described in section 20 of the Trusts Act 1882 (II of 1882), or in the purchase of immovable property or in such other manner, as it may determine, with the like power of varying such investments;
 - (viii) receive and manage any property transferred, grants, bequests, trusts, gifts, donations, endowments and other contributions made to the University;
 - (ix) determine the form, custody and regulation of the use of the common seal of the University;
 - (x) provide buildings, libraries, premises, furniture, apparatus, equipment and other means required for carrying out the work of the University;

- (xi) establish and maintain halls of residence and hostels or approve or license hostels or lodgings for the residence of students;
- (xii) affiliate or disaffiliate colleges and institutes;
- (xiii) admit educational institutions to the privileges of the University and withdraw such privileges;
- (xiv) arrange for the inspection of the academic departments;
- (xv) institute Professorships, Associate Professorships, Assistant Professorships, Lecturerships and other posts and to suspend or abolish such posts;
- (xvi) create, suspend or abolish such administrative, technical, research, extension or other posts as may be necessary;
- (xvii) appoint University teachers and other officers on the recommendation of the Selection Board for teaching and other managerial posts;
- (xviii) confer, with prior approval of the Chancellor, an honorary degree on a person of eminence;
- (xix) prescribe the duties of the officers, teachers and other employees of the University and of those working in the University on deputation or on contract;
- (xx) appoint members to the various Authorities, committees and bodies in the prescribed manner;
- (xxi) remove any person from the membership of any Authority if such person has accepted any assignment which involves absence from the University for a continuous period of six months or more;
- (xxii) regulate, determine and administer, all other matters concerning the University and to this end exercise all necessary powers not specifically mentioned in this Act and statutes but not inconsistent with the provisions of the Act;
- (xxiii) appoint Professor Emeritus on such terms and conditions as may be prescribed;
- (xxiv) suspend, punish and remove from service in the prescribed manner officers, teachers and employees whom it is empowered to appoint;
- (xxv) consider and approve regulations recommended by the Academic Council;
- (xxvi) approve statutes and recommend those drafts of the statutes, for approval of the Chancellor, which pertain to terms and conditions of service of the University employees; and
- (xxviii) perform such other functions as may be assigned to it under the Act and the statutes.
- (3) The Syndicate may delegate any of its functions to an Authority or officer or a committee or sub-committee except the following functions:
 - (a) approval of statutes or recommendation of the drafts of the statutes to the Chancellor:
 - (b) approval of regulations;
 - (c) approval of annual budget of the University, annual report, the annual and revised budget estimates and re-appropriation of funds from one major head of expenditure to another;
 - (d) approval of investment or purchase of immovable property by the University; and
 - (e) transfer of immovable property of the University.
- 22. Academic Council. (1) The Academic Council shall consist of-
 - (a) Vice Chancellor (Chairman);
 - (b) Pro-Vice Chancellor;
 - (c) Deans;
 - (d) Director of Advanced Studies, Research and Technological Development;

- (e) two senior most Professors, other than ex-officio members, from each academic department;
- (f) all Professors Emeritus;
- (g) chairpersons of the academic departments;
- (h) four University teachers, other than Professors, two from each category of Associate professors and Assistant Professors, to be appointed by the Syndicate;
- (i) three persons, including at least one woman, of eminence in sciences, information technology and engineering, of whom one shall be from each category, to be nominated by the Chancellor in consultation with the Vice-Chancellor;
- (j) Secretary to Government, Higher Education Department or his nominee not below the rank of Deputy Secretary;
- (k) Director Public Instruction (Colleges);
- (I) Director, Technical Education;
- (m) Librarian of the University;
- (n) Controller of Examinations;
- (o) five experts in the field of education to be nominated by the Chancellor; and
- (p) Registrar (Member/Secretary).
- (2) <u>A member</u> of the Academic Council appointed by nomination shall hold office for three years.
- (3) The quorum for a meeting of the Academic Council shall be one-third of the total number of members, a fraction being counted as one.
- 23. Powers and duties of the Academic Council.— (1) The Academic Council shall be the academic body of the University and may lay down proper standards of instruction, research, publication and examination and to regulate and promote the academic life of the University and affiliated colleges.
- (2) In particular and without prejudice to the generality of the foregoing provision, the Academic Council may-
 - (i) advise the Syndicate on academic matters;
 - (ii) regulate teaching, research and examinations;
 - (iii) regulate the admission of students to the courses of studies and examinations of the University and affiliated colleges;
 - (iv) regulate the award of studentships, scholarships, medals and prizes;
 - (v) regulate the conduct and discipline of students of the University and affiliated colleges;
 - (vi) propose to the Syndicate schemes for the constitution and organization of faculties, institutes and other academic bodies;
 - (vii) propose regulations on the recommendations of the Boards of Faculties and the Boards of Studies for consideration and approval of the Syndicate;
 - (viii) propose for each academic year, on the recommendations of the Boards of Studies, regulations prescribing the courses of studies, the syllabi and the outlines of tests for all examinations; provided that, if the recommendations of a Board of Faculties or the Board of Studies are not received by the prescribed date, the Academic Council may, subject to the approval of the Syndicate, permit such regulations to continue for the following years;
 - (ix) recognize the examinations of other Universities or examining bodies as equivalent to the corresponding examinations of the University;
 - (x) appoint members to the Authorities in accordance with the provisions of this Act; and
 - (xi) perform such other functions as may be prescribed by the statutes or assigned by the Syndicate.
- 24. Board of Faculty.— (1) There shall be a Board of Faculty for each faculty which shall consist of—
 (a) Dean of the faculty (Chairperson);

- (b) Professors and the chairpersons in the faculty;
- (c) two teachers to be nominated by the Academic Council on the basis of their specialized knowledge of the subjects which, though not assigned to the faculty, have in the opinion of the Academic Council, important bearing on the subjects assigned to the faculty;
- (d) two experts in the field from outside the University to be appointed by the Syndicate; and
- (e) one member to be nominated by the Vice Chancellor.
- (2) The members other than *ex-officio* members of a Board of faculty shall hold office for a period of three years.
- (3) The quorum for a meeting of a Board of faculty shall be one half of the total number of members, a fraction being counted as one.
- (4) A Board of faculty, subject to the general control of the Syndicate and Academic Council, may-
 - (a) co-ordinate the teaching and research work in the subjects assigned to the faculty;
 - (b) scrutinize the recommendations of a Board of Studies comprising a faculty with regard to the appointment of paper setters and examiners for graduate and postgraduate examinations and to forward the panels of suitable paper setters and examiners for each examination to the Vice Chancellor:
 - (c) consider any other academic matter relating to the faculty and to submit its report to the Academic Council;
 - (d) prepare a comprehensive annual report regarding the performance of each department, constituent college or Institute comprising the faculty for presentation to the Academic Council; and
 - (e) perform such other functions as may be prescribed by statutes.

25. Board of Advanced Studies and Research.— (1) The Board of Advanced Studies and Research shall consist of—

- (a) Vice Chancellor (Chairperson);
- (b) all the Deans;
- (c) Controller of Examinations;
- (d) one University Professor from each faculty to be nominated by the Syndicate;
- (e) one member to be nominated by the Vice Chancellor;
- (f) three members, including at least one woman, from the relevant field, research organizations and Government, to be nominated by the Syndicate; and
- (g) Registrar (Secretary).
- (2) The term of office of the members of the Board of Advanced Studies and Research, other than *ex-officio* members, shall be three years.
- (3) The quorum for a meeting of the Board of Advanced Studies and Research shall be one half of the total number of members, a fraction being counted as one.

26. Functions of the Board of Advanced Studies and Research.— The Board of Advanced Studies and Research shall—

- (a) advise an Authority on all matters connected with the promotion of advanced studies and research publication in the University;
- (b) consider and report to an Authority with regard to a research degree of the University;
- (c) propose regulations regarding the award of a research degree;
- (d) appoint supervisors for a postgraduate research student and to approve title and synopsis of a thesis or dissertation;
- (e) recommend panels of names of examiners for evaluation of a research examination; and
- (f) perform such other functions as may be prescribed by the statutes.

27. Selection Board. - (1) The Selection Board shall consist of-

- (a) Vice Chancellor (Chairperson);
- (b) Dean of the faculty concerned;

- (c) chairperson concerned;
- (d) one member of the Syndicate to be nominated by the Syndicate;
- (e) one eminent scholar to be nominated by the Syndicate;
- (f) two experts to be nominated by the Government; and
- (g) Registrar (Secretary).
- (2) The members, other than ex-officio members, shall hold office for a period of three years.
- (3) Five members including at least one expert shall constitute the quorum for a meeting of the Selection Board.
- (4) No member who is a candidate or whose family member is a candidate, for a post to which appointment is to be made, shall take part in the proceedings of the Selection Board for selection of a candidate on such post.
- (5) In selection of candidates for the post of Professor or Associate Professor, the Selection Board shall co-opt or consult three experts in the subject and in selecting candidates for any other teaching post, two experts in the subject, to be nominated by the Vice Chancellor from a standing list of experts for each subject approved by the Syndicate.
- (6) The Syndicate may approve or revise the standing list of experts of a subject on the recommendation of the Selection Board.

28. Functions of the Selection Board. - The Selection Board shall-

- (a) consider the applications and recommend to the Syndicate, the names of suitable candidates for appointment to teaching and other posts and recommend suitable salary for the selected candidate; and
- (b) consider all cases of promotion or selection of officers of the University and recommend the names of suitable candidates for such promotion or selection to the Syndicate.

29. Finance and Planning Committee .- (1) The Finance and Planning Committee shall consist of-

- (a) Vice Chancellor (Chairperson);
- (b) all the Deans;
- (c) one member of the Syndicate to be nominated by the Syndicate;
- (d) one member of the Academic Council to be nominated by the Academic Council;
- (e) one representative each from Higher Education Department and Finance Department of the Government not below the rank of a Deputy Secretary;
- (f) Director Planning or any other nominee of the Commission;
- (g) Registrar; and
- (h) Treasurer (Secretary).
- (2) The term of office of the nominated members shall be three years.
- (3) <u>Six</u> members of the Finance and Planning Committee shall constitute the quorum for a meeting of the Finance and Planning Committee.

30. Functions of the Finance and Planning Committee.— The Finance and Planning Committee shall—

- (a) prepare the annual statement of accounts and propose annual budget estimates and make recommendations to the Syndicate;
- (b) review periodically the financial position of the University;
- (c) advise the Syndicate on all matters relating to finance, investments and accounts of the University; and
- (d) perform such other functions as may be prescribed by the statutes.
- **31. Appointment of Committees by Authorities.** Any Authority may constitute such standing, special or advisory <u>committee</u> as it may deem fit, and <u>may</u> appoint on such committees such persons as are not its members.

CHAPTER V STATUTES, REGULATIONS AND RULES

- **32. Statutes.** (1) Subject to the provisions of this Act, the Syndicate may make statutes or recommend statutes relating to the matters specified in clauses (i) and (ii) of sub-section (2) to the Chancellor.
 - (2) The statutes may be made to provide for and regulate all or any of the following matters:-
 - scales of pay, method of recruitment and other terms and conditions of service of officers, teachers and other employees of the University and the constitution of their pension, insurance, gratuity, provident fund and benevolent fund;
 - (ii) conduct and discipline of the officers, teachers and other employees of the University;
 - (iii) constitution, powers and duties of the Authorities and conduct of elections to such Authorities and related matters;
 - (iv) affiliation and disaffiliation of colleges, institutes, etc. and related matters;
 - (v) admission of educational institutions to the privileges of the University and the withdrawal of such privileges;
 - (vi) establishment of institutes, faculties, colleges, departments and academic divisions;
 - (vii) powers and duties of officers, teachers and employees of the University;
 - (viii) conditions for appointment of Professors Emeritus;
 - (ix) conditions on which the University may enter into arrangements with public bodies or other organizations for purposes of research and advisory services;
 - (x) general scheme of studies including the duration of courses, the system of examinations and the number of subjects and papers for examinations;
 - (xi) award of honorary degrees;
 - (xii) maintenance of register of students and registered graduates;
 - (xiii) conduct of elections for membership of Authorities of the University and related matters; and
 - (xiv) all other matters which are to be prescribed or regulated by the statutes.
- (3) The Syndicate shall recommend statutes under clauses (i) and (ii) of subsection (2) to the Chancellor who may approve it with or without any modification or may refer it back to the Syndicate for reconsideration or may reject it.
- **33. Regulations.** (1) Subject to the provisions of this Act and the statutes, regulations may be made for any of the following matters:-
 - (a) courses of study for degrees, diplomas and certificates of the University;
 - (b) manner in which the recognized teaching referred to in subsection (1) of section <u>4</u> shall be organized and conducted;
 - (c) admission of students to the University;
 - (d) conditions under which students shall be admitted to the courses and examinations of the University and shall become eligible for the award of degrees, diplomas and certificates;
 - (e) conduct of examinations:
 - (f) fees and other charges to be paid by the students for admission to the courses of study and the examinations of the University;
 - (g) conduct and discipline of students;
 - (h) conditions of residence of the students including the levying of fees for residence in halls of residence and hostels:
 - (i) approval and licensing of hostels and lodgings;
 - (j) conditions under which a person should conduct research to entitle him to a degree;
 - (k) institution of fellowships, scholarships, exhibitions, medals and prizes;
 - (I) institution of stipends and free and half-free studentship;
 - (m) academic costumes:
 - (n) use of the library; and
 - (o) establishment of academic departments.

- (2) The Academic Council shall prepare and submit the regulations to the Syndicate and the Syndicate may approve them with or without modifications or refer them back to the Academic Council for reconsideration or reject them.
- **34.** Rules.— (1) An Authority or a body of the University may make rules consistent with this Act, statutes and regulations, to regulate the conduct of its business.
- (2) The Syndicate may direct any Authority or body of the University to amend or repeal any rules made by the Authority or body.

CHAPTER VI UNIVERSITY FUND

35. University Fund.—(1) The University shall have a fund to which shall be credited its income from fees, donations, trusts, bequests, endowments, contributions, grants and all other sources.

(2) The University may accept donations in the shape of land, vehicles, equipment or any other items that may facilitate the functioning of the University and all such donations shall be used, maintained and disposed of by the University in the prescribed manner.

36. Budget, Audit and accounts.— (1) The accounts of the University shall be maintained in such form and in such manner as may be prescribed.

(2) No expenditure shall be made from the University Fund unless a bill for payment has in the prescribed manner, been audited by the Resident Auditor in conformity with the Statutes, Regulations and Rules.

(3) The accounts of the University shall be audited in the prescribed manner once a year by an auditor appointed by the Government in this behalf.

(4) The Syndicate may delegate the power of appropriation or re-appropriation of funds to an officer of the University.

(5) The annual statement of accounts of the University signed by the Treasurer and the Resident Auditor shall be submitted to the Government within six months of the closing of the financial year.

(6) The accounts of the University together with audit objections, if any, and the observations of the <u>Resident Auditor</u> and the Treasurer shall, in the prescribed manner, be presented to the Syndicate with the remarks of the Finance and Planning Committee.

CHAPTER VII MISCELLANEOUS

37. Appeal to Syndicate.— (1) If an order is passed by an Authority, body or officer of the University, other than the Chancellor, and an appeal against the order is not provided under the statutes or the regulations, any aggrieved person may prefer an appeal against the order to the Syndicate.

(2) The Syndicate may constitute a committee of its members to hear and dispose of any

appeal on behalf of the Syndicate.

- (3) If a member of the Syndicate is the officer who passed the order or who is also member of the Authority against whose order appeal is filed before the Syndicate, such member shall not hear the appeal as member of the Syndicate or committee constituted to hear and dispose of the appeal.
- 38. Tripartite Mobility (1) Any officer, teacher of the Government or employee of the University, on the recommendation of the Syndicate, may be directed to serve in any post in the University under the Government or an educational research institution.

(2) The Government may, in consultation with the Selection Board, place the services of an employee of the Government or of any other University or of an educational or research

institution at the disposal of the University in the public interest.

(3) The terms and conditions offered to a person appointed under this section shall not be less favorable than those enjoyed by him immediately before his services are placed at the

disposal of the University, Government or any other institution and full benefit of his previous service shall continue to remain in force until altered in accordance with law.

- **39. Proceedings of Authorities not invalidated by vacancies.** No act, proceeding, resolution or decision of any Authority shall be invalid by reason only of the existence of any vacancy in, or any defect in the constitution of, the Authority.
- **40**. **Transition**.— A Chancellor's Committee shall be constituted by the Chancellor on the recommendations of the Government to exercise the powers assigned to the Syndicate under this Act till such time the Syndicate is constituted in accordance with the provisions of <u>the Act</u>.
- 41. Removal of difficulties.— If any difficulty arises in giving effect to any of the provisions of this Act, the Government may give such directions, not inconsistent with the Act, as it may consider necessary for the removal of such difficulty.
- **42. Indemnity.**—No suit or legal proceedings shall lie against the Government, the University or any Authority, officer or employee of the Government or the University or any person in respect of anything which is done in good faith under this Act.
- 43. Savings Notwithstanding anything contained in this Act, an examination conducted or any act done by the administration of the proposed University prior to the coming into force of the Act, shall be deemed to be the examination conducted or act done by the University under the Act and the University may award degree, diploma or certificate on the basis of such examination.
