### **PROVINCIAL ASSEMBLY OF THE PUNJAB REPORT OF THE STANDING COMMITTEE ON EXCISE AND TAXATION REGARDING THE PROVINCIAL MOTOR VEHICLES (AMENDMENT) BILL 2017 (BILL NO. 29 OF 2017)**

The Provincial Motor Vehicles (Amendment) Bill 2017 (Bill No.29 of 2017) was referred to the Standing Committee on Excise and Taxation on 18 October 2017. The Committee considered the Bill in its meeting held on 2 November 2017.

3. Dr Ahmad Balal, Secretary to Government of the Punjab, Excise, Taxation and Narcotics Control Department and Mr Abid Raza, Deputy Secretary (Legislation), Law and Parliamentary Affairs Department represented their Departments. Mr Faiz-ul-Basit, Additional Secretary (Committees), Provincial Assembly of the Punjab functioned as Secretary to the Committee.

4. Dr Ahmad Balal, Secretary to Government of the Punjab, Excise, Taxation and Narcotics Control Department apprised the Committee about the aims and objects of the Bill. He stated that the Government aimed at ensuring display of security featured number plates and personalized vanity plates for the motor vehicles in the Province. It was necessary to make provision for penalty for the non-display of the security featured number plates and personalized vanity plates to ensure that owners of the motor vehicles display the plates provided by the prescribed authority or registering authority. He requested the Committee that the Bill, as introduced, may be recommended to be passed by the Assembly.

5. The Committee after hearing the Members, having the view point of the Administrative, Law and Parliamentary Affairs Departments and discussing various points, unanimously decided to recommend that the Bill, may be passed by the Assembly subject to the following amendment —

#### **AMENDMENT IN THE BILL**

##### **CLAUSE 2**

For the expressions “Rs.2000”, “Rs.5000” and “Rs.8000”, the expressions “Rs.1000”, “Rs.2000” and “Rs.5000” be substituted respectively.

*further to amend the Provincial Motor Vehicles Ordinance, 1965.*

It is necessary further to amend the Provincial Motor Vehicles Ordinance, 1965 (XIX of 1965) prescribing penalty to be imposed for the non-display on a motor vehicle the security featured number plate or, as the case may be, the vanity plate provided to the owner by the prescribed authority or registering authority.

Be it enacted by Provincial Assembly of the Punjab as follows:

**1. Short title and commencement.**— (1) This Act may be cited as the Provincial Motor Vehicles (Amendment) Act 2017.

(2) It shall come into force at once.

**2. Insertion in Twelfth Schedule of Ordinance XIX of 1965.**— In the Provincial Motor Vehicles Ordinance, 1965 (XIX of 1965), in Twelfth Schedule, after Sr. No. 23, the following new entry at Sr. No. 23-A shall be inserted:

**STATEMENT OF OBJECTS AND REASONS**

The Government aims at ensuring display of security featured number plates and personalized vanity plates for the motor vehicles in the Province. It is necessary to make provision for penalty for the non-display of the security featured number plates and personalized vanity plates to ensure that owners of the motor vehicles display the plates provided by the prescribed authority or registering authority. Hence this Bill.
