He stated that it was necessary to amend the Fatima Jinnah Medical University Lahore Act 2015 (XXIV of 2015) for enhancing upper age limit for the post of Vice Chancellor and revision of eligibility criteria for the post. He requested the Committee that the Bill, as introduced, may be recommended to be passed by the Assembly.

5. The Committee after hearing the Members, having the view point of the Administrative Department as well as Law & Parliamentary Affairs Department and discussing various points, unanimously decided to recommend that the Bill may be passed by the Assembly subject to the following amendment:-

in sub-clause (1), the figures "2015" be substituted by the figures "2016".

THE FATIMA JINNAH MEDICAL UNIVERSITY LAHORE (AMENDMENT) BILL 2015

Bill

to amend the Fatima Jinnah Medical University Lahore Act 2015.

It is necessary to amend the Fatima Jinnah Medical University Lahore Act 2015 (XXIV of 2015) for enhancing upper age limit for the post of Vice Chancellor and revision of eligibility criteria for that post.

Be it enacted by Provincial Assembly of the Punjab as follows:

- Short title and commencement.— (1) This Act may be cited as the Fatima Jinnah Medical University Lahore (Amendment) Act 2015.
 - It shall come into force at once.
- Amendment in section 12 of Act XXIV of 2015.- In the Fatima Jinnah Medical University Lahore Act 2015 (XXIV of 2015), in section 12:
 - (a) in subsection (1), for the words "sixty one", the words "sixty five" shall be substituted; and
 - (b) for subsection (2), the following shall be substituted:
 - A person shall not be eligible for the post of Vice Chancellor unless the person:
 - (a) is MBBS or equivalent;
 - (b) holds such additional qualification in clinical subjects or in basic medical sciences as may be notified by the Government;
 - (c) has experience in undergraduate and postgraduate medical teaching including experience administrative and financial management;
 - (d) has published a minimum of eight quality research publications as professor in the indexed medical journals recognized by the Commission and the Pakistan Medical and Dental Council; and
 - (e) is, has been or is qualified to be a professor in a medical college, an institute or a university.".
- Repeal.- The Fatima Jinnah Medical University Lahore (Amendment) Ordinance, 2015 (II of 2016) is hereby repealed.

It is necessary to amend the Fatima Jinnah Medical University Lahore Act 2015 (XXIV of 2015) for enhancing upper age limit for the post of Vice Chancellor and revision of eligibility criteria for that post.

Be it enacted by Provincial Assembly of the Punjab as follows:

- 1. Short title and commencement.— (1) This Act may be cited as the Fatima Jinnah Medical University Lahore (Amendment) Act 2016.
 - (2) It shall come into force at once.
- 2. Amendment in section 12 of Act XXIV of 2015.— In the Fatima Jinnah Medical University Lahore Act 2015 (XXIV of 2015), in section 12:
 - (a) in subsection (1), for the words "sixty one", the words "sixty five" shall be substituted; and
 - (b) for subsection (2), the following shall be substituted:
 - "(2) A person shall not be eligible for the post of Vice Chancellor unless the person:
 - (a) is MBBS or equivalent;
 - (b) holds such additional qualification in clinical subjects or in basic medical sciences as may be notified by the Government;
 - (c) has experience in undergraduate and postgraduate medical teaching including experience in administrative and financial management;
 - (d) has published a minimum of eight quality research publications as professor in the indexed medical journals recognized by the Commission and the Pakistan Medical and Dental Council; and
 - (e) is, has been or is qualified to be a professor in a medical college, an institute or a university.".
- 3. Repeal.— The Fatima Jinnah Medical University Lahore (Amendment) Ordinance, 2015 (II of 2016) is hereby repealed.
