### PROVINCIAL ASSEMBLY OF THE PUNJAB

#### REPORT OF THE STANDING COMMITTEE ON INDUSTRIES REGARDING THE PUNJAB TECHNICAL EDUCATION AND VOCATIONAL TRAINING AUTHORITY (AMENDMENT) BILL 2015 (BILL NO. 43 OF 2015)

The Punjab Technical Education and Vocational Training Authority (Amendment) Bill 2015 (Bill No. 43 of 2015) was referred to the Standing Committee on Industries on 27 August 2015. The Committee considered the Bill in its meeting held on 13 October 2015.

2. The following were present:—

3. Mr Nabeel Javed, Secretary to Government of the Punjab, Industries, Commerce and Investment Department and Mr Mohsin Bukhari, Deputy Director, Law and Parliamentary Affairs Department, represented their Departments. Hafiz Muhammad Shafiq Adil, Special Secretary, Provincial Assembly of the Punjab functioned as Secretary to the Committee.

4. The Secretary to Government of the Punjab, Industries, Commerce and Investment Department apprised the Committee about the aims and objects of the Bill. He said that the Government had decided to delink the Punjab Board of Technical Education (PBTE) from the Technical Education and Vocational Training Authority (TEVTA). For that purpose, certain amendments in the Punjab Technical Education and Vocational Training Authority Act, 2010 (X of 2010) were necessary to effect administrative and operational autonomy to the Punjab Board of Technical Education (PBTE) to enable it independently to perform its assigned functions. He requested the Committee that the Bill, as introduced, may be recommended to be passed by the Assembly.

5. The Committee after hearing the Members, having the view point of the Administrative Department & Law and Parliamentary Affairs Department and discussing various points, unanimously decided to recommend that the Bill may be passed by the Assembly subject to the following amendments:—

**AMENDMENTS IN THE BILL**

**(1) LONG TITLE**

before the word "to" occurring in the beginning, the word "further" be added.

**(2) PREAMBLE**

before the word "amendments" occurring in line 1, the word "further" be added.

**(3) CLAUSE 2**

in Section (5) of the Principal Act, after marginal heading, the expression (1), be omitted.

6. A copy of the Bill as introduced in the Assembly is at Annexure-A and a copy of the Bill as recommended by the Committee is at Annexure-B.

Certain amendments in the Punjab Technical Education and Vocational Training Authority Act 2010 (X of 2010) are necessary to effect administrative and operational autonomy to the Punjab Board of Technical Education to enable it independently to perform its assigned functions.

Be it enacted by Provincial Assembly of the Punjab as follows:

- 1. Short title and commencement.**— (1) This Act may be cited as the Punjab Technical Education and Vocational Training Authority (Amendment) Act 2015.  
(2) It shall come into force at once.
- 2. Amendment in section 5 of Act X of 2010.**— In the Punjab Technical Education and Vocational Training Authority Act 2010 (X of 2010), in section 5, subsection (2) shall be omitted.
- 3. Repeal.**— The Punjab Technical Education and Vocational Training Authority (Amendment) Ordinance, 2015 (XXIV of 2015) is hereby repealed.
