REPORT OF THE STANDING COMMITTEE ON RELIGIOUS AFFAIRS AND AUQAF REGARDING THE PUNJAB INSTITUTE OF QURA'N AND SEERAT STUDIES (AMENDMENT) BILL 2015 (BILL NO. 32 OF 2015)

The Punjab Institute of Qura'n and Secrat Studies (Amendment) Bill 2015 (Bill No. 32 of 2015) was referred to the Standing Committee on Religious Affairs and Auquaf on 10 June 2015. The Committee considered the Bill in its meeting held on 27 July 2015.

- 3. Mr Shafiq Ahmad, Additional Secretary, Government of the Punjab, Auqaf and Religious Affairs Department and Mr Mohsin Bukhari, Deputy Director, Law and Parliamentary Affairs Department represented their Departments. Hafiz Muhammad Shafiq Adil, Special Secretary, Provincial Assembly of the Punjab functioned as Secretary to the Committee.
- 4. The Additional Secretary, Religious Affairs and Auqaf Department apprised the Committee about the aims and objects of the Bill. He said that the Government had decided to amend the Punjab Institute of Quran and Secrat Studies Act 2014 (XXIX of 2014) for purposes of rationalizing membership of the Board of Directors and Academic Council of the Institute. He requested the Committee that the Bill may be recommended for passage by the Assembly.
- 5. The Committee after hearing the Members, having the view point of the Administrative Department, Law and Parliamentary Affairs Department and discussing various points, unanimously decided to recommend that the Bill may be passed by the Assembly subject to the following amendments:-

AMENDMENTS IN THE BILL

(1) CLAUSE 3

in the amendment at (a) (i), in the proposed clause (k) of subsection (1) of Section 5 of the Principal Act, the word "Madris", be substituted by the word "Madaris".

(2) CLAUSE 4

in the proposed clause (d) of subsection (2) of Section 12 of the Principal Act, the word "Madris", be substituted by the word "Madaris".

6. A copy of the Bill as introduced in the Assembly is at Annexure-A and a copy of the Bill as recommended by the Committee is at Annexure-B.

THE PUNJAB INSTITUTE OF QURA'N AND SEERAT STUDIES (AMENDMENT) BILL 2015

A BILL

to amend the Punjab Institute of Qura'n and Seerat Studies Act 2014. It is expedient to amend the Punjab Institute of Quran and Seerat Studies Act 2014 (XXIX of 2014) for purposes of rationalizing membership of the Board of Directors and Academic Council of the Institute and for other purposes;

Be it enacted by the Provincial Assembly of the Punjab as follows:

- 1. Short title and commencement.— (1) This Act may be cited as the Punjab Institute of Qura'n and Secret Studies (Amendment) Act 2015.
 - (2) It shall come into force at once.
- 2. Amendment in section 2 of Act XXIX of 2014.— In the Punjab Institute of Qura'n and Secrat Studies Act 2014 (XXIX of 2014), for brevity cited as the said Act, for section 2, the following shall be substituted:
 - "2. Definitions.— In this Act:
 - (a) "Academic Council" means Academic Council of the Institute;
 - (b) "Board" means Board of Directors of the Institute;
 - (c) "Executive Director" means Executive Director of the Institute;
 - (d) "Government" means Government of the Punjab;
 - (e) "Institute" means Punjab Institute of Qura'n and Seerat Studies established under the Act; and
 - (f) "prescribed" means prescribed by rules or regulations made under the Act."
- 3. Amendment in section 5 of Act XXIX of 2014.—In the said Act, in section 5:
 - (a) in subsection (1):
 - (i) for clause (k), the following shall be substituted:
 - "(k) President and General Secretary of Ittehad Tanzimat-e-Madris-e-Pakistan;

 - (ii) after clause (k), the following clause (kk) shall be inserted:
 - "(kk) one eminent scholar to be Member".

 nominated by the Government;
 - (b) for subsection (4), the following shall be substituted:
 - "(4) The Government shall nominate members of the Board, other than ex-officio members, for a term of two years but the member shall serve during the pleasure of the Government."
- 4. Amendment in section 12 of Act XXIX of 2014.— In the said Act, in section 12, in subsection (2), for clause (d), the following shall be substituted: "(d) one nominee of Ittehad Tanzimat-e-Madris-e-Pakistan:"
- **5. Repeal.** The Punjab Institute of Qura'n and Seerat Studies (Amendment) Ordinance, 2015 (XV of 2015) is hereby repealed.
