PROVINCIAL ASSEMBLY OF THE PUNJAB REPORT OF THE STANDING COMMITTEE ON AGRICULTURE REGARDING RESOLUTION NO.238/16 MOVED BY CH AAMIR SULTAN CHEEMA, MPA (PP-32) AND RESOLUTION NO.276/16 MOVED BY MR AHMED KHAN BHACHER, MPA (PP-45)

Resolution No.238/16 moved by Ch Aamir Sultan Cheema, MPA (PP-32) and Resolution No.276/16 moved by Mr Ahmed Khan Bhacher, MPA (PP-45) (Annexed) were referred to the Standing Committee on Agriculture on 12 May 2016 and 23 May 2016 respectively. 4. Ch Aamir Sultan Cheema, MPA and Mr Ahmed Khan Bhacher, MPA raised their concerns about the procedure of procurement of wheat as well as uneven distribution of ganny bags to the farmers in different areas of the Punjab.
5. The Secretary to Government of the Punjab, Food Department assured the Committee that all the issues of the Movers and the Committee Members would be redressed in the next wheat procurement policy. He further assured that provision of Ganny Bags to Rajanpur, Rahim Yar Khan Districts and Bahawalpur Division would be dealt ten days prior to other Districts/Divisions in the next year.
6. The Committee was satisfied with the explanation given by the Secretary, Food Department and decided to dispose of the subject Resolutions.
