# THE NEXT INSTITUTE OF SCIENCE AND TECHNOLOGY (AMENDMENT) BILL 2025

A

Bill

to amend the Next Institute of Science and Technology Act 2025.

It is expedient to amend the Next Institute of Science and Technology Act 2025 (XXX of 2025) for the purposes hereinafter appearing.

Be it enacted by Provincial Assembly of the Punjab as follows:

- Short title and commencement.— (1) This Act may be cited as the Next Institute
  of Science and Technology (Amendment) Act 2025.
  - (2) It shall come into force at once.
- 2. Amendment of Section 4 of Act XXX of 2025.— In the Next Institute of Science and Technology Act 2025 (XXX of 2025), hereinafter referred to as 'the Act', in section 4:
  - (i) in clause (a), in para (i), after the expression "Faculty of Law;", the expression "Faculty of Allied Health Sciences;", shall be inserted; and
  - (ii) in the proviso, the words "listed above or", shall be omitted.
- 3. Amendment of Section 6 of Act XXX of 2025.— In section 6, in sub-section (2), for the word "ten", the word "three;", shall be substituted.
- 4. Amendment of Section 12 of Act XXX of 2025.— In section 12, for the words "as it may deem fit" the words "on the recommendations of the Board", shall be substituted.
- 5. Addition of section 31 of Act XXX of 2025.— after section 30, the following new section 31, shall be added:
  - **"31. Savings.** Notwithstanding anything contained in this Act, an examination conducted by the affiliating public sector Universities prior to the coming into force of the Act, shall be deemed to be the examination conducted by the Institute under the Act, the Institute may award degree, diploma or certificate on the basis of such examination, subject to the consenting choice of already enrolled students."
- 6. Amendment of the Schedule of Act XXX of 2025.— In the Schedule, in Paragraph 1, in sub-paragraph (2), after clause (a), the following new clause (b) shall be added and remaining clauses be renumbered accordingly:
  - "(b) Faculty of Allied Health Sciences;".
