REPORT OF THE STANDING COMMITTEE ON REVENUE, RELIEF AND CONSOLIDATION REGARDING THE PUNJAB LAND REVENUE (AMENDMENT) BILL 2019 (BILL NO.17 OF 2019)

The Punjab Land Revenue (Amendment) Bill 2019 (Bill No.17 of 2019) was referred to the Standing Committee on Revenue, Relief and Consolidation on 13 June 2019. The Committee considered the Bill in its meeting held on 9 August 2019.

3. Engineer Amjad Shoaib Khan, Secretary (Revenue), Board of Revenue Punjab Lahore and Mr Mohsin Bukhari, Additional Director, Law and Parliamentary Affairs Department represented their Departments. Mr Innayat Ullah Lak, Director General Parliamentary Affairs and Research, Provincial Assembly of the Punjab, functioned as Secretary to the Committee.

4. The Secretary (Revenue), Board of Revenue Punjab Lahore apprised the Committee about the aims and objects of the proposed Bill. He stated that it was necessary further to Amend the Punjab Land Revenue Act, 1967 (XVII of 1967) to exclude certain land from operation of Act *ibid*. He requested the Committee to recommend the Bill to be passed by the Assembly.

5. The Committee after hearing the Members, having view point of the Board of Revenue as well as Law and Parliamentary Affairs Department; and discussing various points, unanimously decided to recommend that the Bill may be passed by the Assembly as introduced.

THE PUNJAB LAND REVENUE (AMENDMENT) BILL 2019.

A
Bill

to amend the Punjab Land Revenue Act, 1967.

It is necessary further to amend the Punjab Land Revenue Act, 1967 (*XVII of 1967*) to exclude certain land from operation of the Act *ibid*.

Be it enacted by Provincial Assembly of the Punjab as follows:

1. Short title and commencement.— (1) This Act may be cited as the Punjab Land Revenue (Amendment) Act 2019.

(2) It shall come into force at once.

2. Amendment in section 3 of Act XVII of 1967.— In the Punjab Land Revenue Act, 1967 (*XVII of 1967*), for section 3, the following shall be substituted:

“3. Exclusion of certain land from operation of this Act.— The provisions of this Act relating to assessment and collection of land revenue shall not be applicable to an area notified by the Board of Revenue.”

3. Repeal.— The Punjab Land Revenue (Amendment) Ordinance 2019 (IV of 2019) is hereby repealed.
